## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 2 TO THE PERSONAL SERVICES CONTRACT WITH COMMUNITY RECOVERY RESOURCES (CORR) FOR THE PROVISION OF PERINATAL AND NON-PERINATAL OUTPATIENT DRUG TREATMENT AND INTENSIVE OUTPATIENT DRUG TREATMENT SERVICES FOR FISCAL YEAR 2018/19 (RESOLUTIONS 18-389 & 18-532)**

WHEREAS, on August 14, 2018, per Resolution 18-389, the Nevada County Board of Supervisors approved a renewal contract with Community Recovery Resources (CoRR) for the provision of services for the prevention, treatment and recovery of alcohol and drug dependency for the term of July 1, 2018 through June 30, 2019; and

WHEREAS, on November 13, 2018, per Resolution 18-532, the Nevada County Board of Supervisors approved Amendment No. 1 to the Personal Services Contract to incorporate funding for additional services received from the Community Based Transitional Housing Grant through the State Department of Finance, thereby increasing the maximum contract price to \$1,243,562 (an increase of \$61,351); and

WHEREAS, the Parties desire to enter into an Amendment No. 2 to the Personal Services Contract to: 1) incorporate funds received from the Health Resources and Services Administration (HRSA) for the Rural Health Opportunity Program (RHOP); 2) increase the Maximum Contract price from \$1,743,562 to \$1,930,118 (an increase of \$186,556); and 3) amend the Exhibit "A" Schedule of Services," and Exhibit "B" Schedule of Charges and Payments, to reflect the additional services and increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 2 to the Personal Services Contract by and between the County and Community Recovery Resources for the provision of Perinatal and Non-Perinatal Outpatient Drug Free (ODF) Treatment and Intensive Outpatient Treatment (IOT) Services for substance using pregnant and/or parenting women, men and adolescents; Comprehensive Residential Treatment Program Services for the recovery of alcohol/drug dependency; and Substance Abuse Prevention and Treatment Services, to residents of Nevada County, increasing the maximum contract price to \$1,930,118 (an increase of \$186,556) for the term of July 1, 2018 through June 30, 2019, and amending the Exhibit "A" Schedule of Services, and Exhibit "B" Schedule of Charges, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
