BACKGROUND:

Currently, there are five positions available July 1, 2022 for the Local Planning Council for Child Care Development for the County of Nevada (formerly Child Care Coordinating Council). One Child Care Provider, one Community Member, two Consumer Member, and one Chair of the Board of Supervisors Public Agency representative, all to fill two-year terms beginning July 1, 2022 and ending June 30, 2024. These positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Justine Riley submitted an application for reappointment to the Child Care Coordinating Council on May 23, 2022. Justine Riley has served on the Council since September 13, 2016 as a Child Care Provider Member. Justine will be redesignated from Child Care Provider Member to Public Agency Member.

Sandra Boone submitted an application for reappointment as Community Member on June 2, 2022. Sandra Boone has served on the Council since January 6, 1998.

Lauren Garrison submitted an application for reappointment as Consumer Member on June 20, 2022. Lauren Garrison has served on the Council since November 8, 2016.
