SUBJECT: Resolution approving Contract with HDR Construction Control Corporation Inc. for Construction Management and Inspection Services for the Dog Bar Road over Bear River Bridge Replacement Project Federal No. BRLO 05917-084, County Project No. 224024 for \$1,127,518.93 plus a 10% contingency of \$112,751.89 for a total amount not to exceed \$1,240,270.82 and authorizing the Chair of the Board of Supervisors to Execute the Contract – District II

RECOMMENDATION: Approve the attached Resolution

FUNDING: This project is funded by the Highway Bridge Program (HBP) funds and is included in the proposed FY 2024/25 Road Capital Improvement budget. Funding for this project has been programed and obligated by Caltrans. Staff is awaiting the final E76 from the State approving the start of construction. A notice to proceed will not be issued without the E76 approval from Caltrans. No budget amendment is necessary, and there is no impact to the General Fund.

BACKGROUND: Dog Bar Road over the Bear River bridge has been deemed structurally deficient by the State of California. The State has agreed to fund replacement of this structure. However, the County does not have the staffing or expertise to provide construction oversight of this project.

On October 10, 2023, the County released a Request for Proposals (RFP) for professional engineering services for Construction Management and Inspection functions and received one proposal from HDR Construction Control Corporation Inc. (HDR). On November 3, 2023, the County readvertised and again received only one proposal from HDR for providing construction management services and inspection for the Replacement of the Dog Bar Road Bridge.

The County performed an independent cost estimate and determined that the cost proposal from HDR was acceptable. HDR did meet the Disadvantaged Business Enterprise (DBE) goal of 18%.

It is recommended that the contract be awarded to HDR Construction Control Corporation Inc, at the price of \$1,127,518.93 plus a 10% contingency of \$112,751.89 for a total of \$ 1,240,270.82. Work is expected to begin in fall/winter of 2024.
