The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County, develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owners, and all others for wise conservation and management of resources to benefit the County's agricultural assets, and maintain an active Agricultural Commission to advise the County on agricultural-related matters.

AGRICULTURAL ADVISORY COMMISSION

Ord. 991, 2076, 2148, 2211, 2417

The Agricultural Advisory Commission shall consist of nine members appointed by the Board of Supervisors and serve four year terms and until the appointment and qualification of their successor. Commissioners serve at the pleasure of the Board of Supervisors. Any vacancy created during a term shall be filled by the Board of Supervisors for the remainder of the unexpired term.

Regular meetings shall be on the third Wednesday of January, March, May, July, September, and November. All meetings are held in the Board Chambers of the Eric Rood Administrative Center, unless otherwise noticed. All meetings convene at 6 p.m
