SUBJECT: Reappointments to the Nevada County Mental Health and Substance Use Advisory Board

RECOMMENDATION: Approve the reappointments of Iden Rogers as Consumer Member representative, David Davidson-Methot as Member representative and Anne Rarick as Family Member representative to the Nevada County Mental Health and Substance Use Advisory Board, for three-year terms ending June 30, 2029.

BACKGROUND:

Currently, there are three positions and two vacancies open on the Mental Health and Substance Use Advisory Board: three positions for Member, Consumer Member and Family Member for unexpired terms beginning July 1, 2026, and ending June 30, 2029. One member vacancy to fill a three-year term ending June 30, 2026; and one Consumer member vacancy to fill a three-year term ending June 30, 2028. These vacancies can be filled by Consumer, Family or General Members. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, in the Board of Supervisors Office, Truckee Town Hall, the District V Board of Supervisors office in Truckee, and on the County website.

Iden Rogers submitted an application to continue to serve on the Mental Health and Substance Use Advisory Board on April 23, 2026. Cari Yardley, Acting Behavioral Health Director, has recommended the reappointment of Iden to the Advisory Board as a Consumer Member.

David Davidson-Methot submitted an application to continue to serve on the Mental Health and Substance Use Advisory Board on April 28, 2026. Cari Yardley, Acting Behavioral Health Director, has recommended the reappointment of David to the Advisory Board as a Member.

Anne Rarick submitted an application to continue to serve on the Mental Health and Substance Use Advisory Board on June 8, 2026. Cari Yardley, Acting Behavioral Health Director, has recommended the reappointment of Anne to the Advisory Board as a Member.

Please consider reappointing Iden Rogers as Consumer Member representative, David Davidson-Methot as Member representative and Anne Rarick as Family Member representative to the Nevada County Mental Health and Substance Use Advisory Board, for three-year terms ending June 30, 2029.
