## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

## RESOLUTION APPROVING AMENDMENT NO. 1 TO CONTRTACT WITH NELSON ENGINEERING FOR PROFESSIONAL ENGINEERING SERVICES FOR AN INCREASE OF \$35,000 TO A MAXIMUM NOT TO EXCEED AMOUNT OF \$75,000 FOR ENGINEERING SERVICES AND AUTHORIZING THE PURCHASING AGENT TO INCREASE THE ENCUMBRANCE

WHEREAS, on August 8, 2024, the Nevada County Purchasing Agent approved purchase order PESS4743 with Nelson Engineering for professional engineering services from July 1, 2024, through June 30, 2025, for a not to exceed amount of \$40,000; and

WHEREAS, additional services are required for processing engineering projects; and

WHEREAS, the parties desire to increase the contract amount by \$35,000 for a new not to exceed amount of \$75,000; and

WHEREAS, contract expenses will be paid from the Road Engineering budget and a budget amendment is not necessary.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves Amendment No. 1, attached hereto, to the Professional Services Contract by and between the County of Nevada and Nelson Engineering, increasing the contact amount by \$35,000 for a maximum not to exceed amount of \$75,000 and the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 1.
- 2. Authorizes the Purchasing Agent to increase encumbrance PESS4743 by \$35,000.
