**BACKGROUND:**

The Board of Supervisors appoints one member from the Greater Truckee Area to represent the needs of children on the First 5 Nevada County Children & Families First Commission. Laura Brown was first appointed to this position on November 12, 2013, and was subsequently reappointed in 2015 and 2017. Ms. Brown's current term expires on October 31, 2019. She submitted her application for reappointment on September 18, 2019, and indicated that she would like to continue serving on the commission.

Currently there is one position becoming available on the First 5 Nevada County Children & Families First Commission for the role Greater Truckee Area member representing the interests of children. This position was advertised and posted for a minimum of ten days on the bulletin boards outside the Board of Supervisors Chambers, Board of Supervisors Office, Madelyn Helling Library, Grass Valley Library, Truckee Library, Truckee Joseph Center, Truckee Town Hall, District V Board of Supervisors Office in Truckee, and on the MyNevadaCounty.com website.
