

**AMENDMENT NO. 1
TO THE AGREEMENT FOR PUBLIC SAFETY DISPATCH SERVICES
BETWEEN THE CITY OF GRASS VALLEY, THE TOWN OF TRUCKEE, THE CITY OF
NEVADA CITY AND THE COUNTY OF NEVADA**

THIS AMENDMENT is executed this ____ day of _____, 2026 by and between THE CITY OF GRASS VALLEY, THE TOWN OF TRUCKEE, THE CITY OF NEVADA CITY and COUNTY OF NEVADA (the "parties"). Said Amendment will amend the prior agreement between the parties entitled Agreement for Public Safety Dispatch Services executed on September 14, 2021, by Resolution No. 21-401.

WHEREAS, the parties desire to amend their agreement to extend the term of the Agreement from June 30, 2026 to September 30, 2026 (three months) and revise Exhibit A – Service Costs to allow for cost reimbursement through the extended term.

NOW, THEREFORE, the parties hereto agree as follows:

1. This amendment shall amend Section 1.1 Effective Dates to extend the term through September 30, 2026.
2. Exhibit A - Service Costs is amended to add the following:
 - The total Regional Dispatch budget for Fiscal Year 2026/27 is \$2,634,811.
 - The City of Grass Valley agrees to pay monthly on an allocated percentage of 29.34% of the annual Regional Dispatch budget or \$773,054, which equates to \$64,421.13 per month or a total of \$139,263.39 for the three-month period.
 - The City of Nevada City agrees to pay monthly on an allocated percentage of 7.88% of the annual Regional Dispatch budget or \$207,623, which equates to \$17,301.93 per month or a total of \$51,905.78 for the three-month period.
 - The Town of Truckee agrees to pay monthly on an allocated percentage of 16.53% of the annual Regional Dispatch budget, which equates to \$36,294.52 per month or a total of \$108,883.56 for the three-month period.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
