OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING THE CAPITAL ASSET EMERGENCY PURCHASE AND INSTALLATION OF AN ADA WHEELCHAIR LIFT AND APPROVING CONTRACT WITH HANKIN SPECIALTY ELEVATORS, INC. IN THE AMOUNT OF \$46,095 AND WITH A 10% CONTINGENCY OF \$4,610 FOR A TOTAL OF \$50,705 FOR THE GRASS VALLEY VETERANS BUILDING AND AMENDING THE FY 23-24 CAPITAL FACILITIES BUDGET IN THE AMOUNT OF \$50,705 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Grass Valley Veterans Building provides Veterans services and essential services in times of cooling shelter activation and other local emergency activations to the County; and

WHEREAS, the two existing ADA wheelchair lifts at the Grass Valley Veterans Building were installed in 2001; and

WHEREAS, one of the ADA wheelchair lifts in the Grass Valley Veterans Hall has recently broken, parts are unavailable due to the Manufacturer going out of business; and

WHEREAS, the new lift is required to be put back in operation by the State Department of Industrial Regulations (DIR) by Sept 2023 and an extension can be granted if progress toward replacing the equipment is made; and

WHEREAS, three bids were received for the replacement of the existing ADA wheelchair lift, and the lowest and most responsive bid was received from Hankin Specialty Elevators Inc of Ranch Cordova, Ca; and

WHEREAS; the contract will be in the bid amount of \$46,095 plus a 10% contingency of \$4,610 for a maximum contract amounts of \$50,705; and

WHEREAS, funding for this project will be paid out of the Fiscal Year 2023-24 Capital Facilities budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, hereby directs that:

1. The Board approves the capital asset emergency purchase and installation of a Garaventa Opal Wheelchair Lift at the Grass Valley Veterans Building, 225 South Auburn Street, Grass Valley, California, in the amount of \$46,095 plus a contingency of \$4,610 for a total contract amount of \$50,705 be awarded to Hankin Specialty Elevators Inc, 3237 Fitzgerald Rd, Ranch Cordova, Ca, 95742.
2. The Board approves and the Purchasing Agent, or designee, is authorized to execute a Nevada County standard public works contract on behalf of Nevada County with Hankin Specialty Elevators, Inc upon receipt, approval, and acceptance of the certificates of insurance.
3. The Purchasing Agent, or designee, is authorized to execute the contract and all documents relating to it and to encumber the funds.
4. Contractor shall commence the work 10 days after mailing of written notice to proceed by County. All work shall be completed and 120 days of the mailing of the Notice to Proceed.
5. The Auditor -Controller is directed to release \$50,705 from the Capital Facilities Assignment of the General Fund and to amend the Fiscal Year 2023-24 Capital Facilities budget as follows:
