SUBJECT: Resolution approving execution of an amendment to the contract with the California Mental Health Services Authority (CalMHSA) for Workforce Education and Training (WET) to remove retention activities from the scope of services. Contract maximum amount is \$71,381.50 for the contract term of July 1, 2021 through June 30, 2025. (RES 22-003)

RECOMMENDATION: Approve the attached Resolution.

FUNDING: This program is funded by Mental Health Services Act (MHSA) dollars. The department is providing a local contribution of MHSA Workforce Education and Training (WET) dollars, which will be matched by the California Department of Health Care Access and Information (HCAI). Services are supported by Realignment dollars. The contract is within the department's FY 2022/23 budget. There are no county general fund dollars required in the agreement.

BACKGROUND: On January 11, 2022, per Resolution 22-003, the Nevada County Board of Supervisors approved execution of with the California Mental Health Services Authority (CalMHSA) for Workforce Education and Training (WET) activities. The 2020-2025 Workforce Education and Training (WET) program aims to address the shortage of mental health practitioners in the public mental health system (PMHS) through a framework that engages Regional Partnerships and supports individuals through five potential categories including: Pipeline Development, Loan Repayment Program, Undergraduate College and University Scholarships, Clinical Master and Doctoral Graduate Education Stipends, and Retention Activities. The Superior Region - consisting of Butte, Colusa, Del Norte, Glenn, Humboldt, Lake, Lassen, Mendocino, Modoc, Nevada, Plumas, Shasta, Sierra, Siskiyou, Tehama, and Trinity County - selected four these three categories as their local priorities: Loan Repayment, Educational Stipend, Peer Scholarships, and Retention Activities.

California Counties under the authority of the Government Code formed the California Mental Health Services Authority (CalMHSA). CalMHSA is authorized by its Joint Exercise of Powers Act to jointly develop, and fund mental health services under, among other services and functions. The Superior Region has partnered with CalMHSA to administer the following activities for the Behavioral Health Workforce: Loan Repayment, Educational Stipend, and Peer Scholarships

Through this contract, CalMHSA serves as the fiscal and administrative agent for the three WET activities. CalMHSA collects and holds county local contribution WET funds and will draw down state HCAI WET match funds. Additionally, CalMHSA will manage awards for Loan Repayment, Education Stipends, and Peer Scholarships, including confirming eligibility, compliance, executing agreement terms and disbursing funds to award recipients.

The original contract referenced Retention Activities as a strategy that CalMHSA would be responsible for. This amendment removes Retention Activities, as this WET program will be administered by another third-party administrator, CIBHS.

It is recommended that the Board approve this Amendment as it more accurately reflects CalMHSA WET programming responsibilities and creates strategies to alleviate the shortage of staffing within the public mental health system.
