OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AN AMENDMENT TO THE RENEWAL CONTRACT WITH THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH (CDPH) TUBERCULOSIS CONTROL BRANCH (TBCB) FOR A REAL-TIME ALLOTMENT (ADMIN NO. 1182)

WHEREAS, per Administrative Contract No. 1182 the County Executive Officer approved the initial funding for the renewal contract with the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) for Fiscal Year 2016/17 which provides financial assistance to local health jurisdictions to support core Tuberculosis (TB) control and prevention activities; and

WHEREAS, the California Department of Public Health Tuberculosis Control Branch has awarded to the Nevada County Public Health Department an additional Real-time Allotment to carry out Nevada County TB Program control efforts.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, approves in substantially the form attached hereto, the amendment to the Agreement by and between the County and the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB), which increases the Real-time Allotment to the maximum amount payable from \$3,650 to \$20,699 (an increase of \$17,049) to support TB prevention and control activities for the Funding Period of July 1, 2016 through June 30, 2017, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

LETTER OF REAL-TIME ALLOTMENT
FUNDING PERIOD: July 1, 2016 through June 30, 2017

This letter is confirmation of your local assistance Real-time Allotment to support TB prevention and control activities in fiscal year (FY) 2016-2017.

ALLOTMENT

The California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) is awarding to the Nevada County Public Health Department a Real-time Allotment of \$17,049, with the understanding that your staff will work with CDPH TBCB staff in carrying out your program's TB control efforts. This allotment is comprised of \$6,577 state and \$10,472 federal funds.* The amount is based on the number of tuberculosis (TB) cases, case characteristics and completed B1-notification evaluations reported by your jurisdiction between June 1 and October 31, 2016. Funds are issued for up to five TB cases and/or case characteristics per calendar year.

This allotment is valid and enforceable only if the enacted State of California FY 2016-2017 budget and the 2016 and 2017 Federal budgets make sufficient funds available for the purposes of this program.

The allotment can be used for allowable expenditures contained in Table 2 (page 13) of the FY 2016-2017 Tuberculosis Control Local Assistance Funds Standards and Procedures Manual including food, shelter, incentives and enablers (FSIE) for TB patients, contacts to TB patients and patients who are suspected of having TB. FSIE items should be used to enhance treatment adherence, prevent homelessness, and/or promote least restrictive alternatives that decrease or obviate the need for detention. To comply with federal restrictions on fund use, reimbursement of medication expenditures is limited to the amount of the state fund portion of the award. Reimbursement of your expenditures is contingent upon compliance with these standards and procedures.
