







# TRUTH ACT



- **Approved by CA Governor Brown on September 26, 2016**
- **Requires NCSO to provide an Incarcerated Person with a written consent form prior to I.C.E. interview**
- **Provides criteria to NCSO for cooperating with Immigration and Customs Enforcement (I.C.E.)**
- **NCSO established policies and procedures**
- **Corrections POLICY 502**
- **Addresses requirements of Government Code 7283-7283.2 and 7282.5**

# Government Codes



- **Government Code 7282.5**
  - Identifies charges and conditions that must be met for Incarcerated Persons to be held for I.C.E.
- **Government Code 7283**
  - Defines which Incarcerated Person data should be presented at the yearly community forum
- **Government Code 7283.1**
  - Outlines process (providing forms, information availability, community forum)
- **Government Code 7283.2**
  - Specifies chapter doesn't change authority to detain based upon an I.C.E. hold



# NCSO POLICY 502.3.2 thru 502.3.5

- **Notify Incarcerated Person if jail receives a hold request from I.C.E.**
  - This notice includes whether NCSO plans to comply with the request
- **One additional person designated by Incarcerated Person will also receive copy of I.C.E. request , if we notify I.C.E. of their pending release (I.E. - an attorney)**
- **All I.C.E. requests for interviews are entirely voluntary**
- **All forms are available in several different languages**



# PROCESS

- Incarcerated Person is booked into Wayne Brown Correctional Facility (WBCF)
- I.C.E. is automatically notified via Live Scan (Fingerprinting)
  - I.C.E. may send a detainer to NCSO
- If I.C.E. places a hold, notification is given to the Incarcerated Person
- If I.C.E. requests to interview an Incarcerated Person, consent forms are given to the Incarcerated Person. The interview is VOLUNTARY
  - If Incarcerated Person consents, they are interviewed by I.C.E.
- I.C.E. receives Notification of Release form, if Incarcerated Person meets criteria



# I.C.E. Access

**“I.C.E. access” means, for the purposes of civil immigration enforcement, including when an individual is stopped with or without their consent, arrested, detained, or otherwise under the control of the local law enforcement agency, all the following:**

- 1) Responding to an I.C.E. hold, notification, or transfer request**
  - WBCF responded to 1
- 2) Providing notification to I.C.E. in advance of the public that an individual is being or will be released at a certain date and time through data sharing or otherwise.**
  - WBCF responded to 1
- 3) Providing I.C.E. non-publicly available information regarding release dates, home addresses, or work addresses, whether through computer databases, jail logs, or otherwise.**
  - WBCF does not provide this information to I.C.E. through databases, jail logs, etc.
- 4) Allowing I.C.E. to interview an individual**
  - I.C.E. did not conduct any interviews.
- 5) Providing I.C.E. information regarding dates and times of probation or parole check-ins.**
  - I.C.E. was not provided with any information regarding probation or parole.



# 2024 Statistics

**Of those incarcerated persons with some level of I.C.E. involvement, there were:**

## **8 Bookings**

- 6 bookings on local charges
- 2 with holds from other agencies
  - Contract agency booking (Placer County-Truckee)
  - Contract agency booking (USMS)

## **8 Releases**

- 4 released to the public
- 1 transported to state prison
- 1 released to contract agency (Placer County)
- 2 released to I.C.E.
  - 1 was time served on Nevada County charges and met conditions of Government Code 7282.5
  - 1 was time served on Federal charges (non I.C.E. related) and met conditions of Government Code 7282.5



# 2024 Statistics Continued

**There was an average daily population of ONE (1) Incarcerated Person with I.C.E. holds in custody at WBCF throughout the year**

**42 days was the average length of stay for Incarcerated Person with I.C.E. holds**

**The increase in the average length of stay over last year is mainly due to two reasons.**


- One Incarcerated Person had a total stay of 255 days for felony charges
- There were fewer incarcerated persons with I.C.E. holds for this year but their time in custody was longer which brought the average up.
