OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT WITH AEGIS TREATMENT CENTERS, LLC FOR THE PROVISION OF A DRUG MEDI-CAL (DMC) OUTPATIENT NARCOTIC TREATMENT PROGRAM (NTP) FOR REFERRED CLIENTS OF THE NEVADA COUNTY BEHAVIORAL HEALTH DEPARTMENT TO ADD ADDITIONAL LANGUAGE REGARDING STAFFING REQUIREMENTS, INCREASE THE MAXIMUM CONTRACT PRICE FROM \$138,437 TO \$300,000 (AN INCREASE OF \$161,563) FOR FISCAL YEAR 2019/20 AND DIRECTS THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2019/20 (RES. 19-472) (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Opioid abuse is a significant challenge for our community, with the rate of opioid prescriptions as well as opioid overdose emergency department visits exceeding the state rate significantly; and

WHEREAS, Contractor has locations in Marysville and Roseville that Nevada County Drug Medi-Cal (DMC) beneficiaries receive Opioid Use Disorder medication assisted treatment and counselling at both sites; and

WHEREAS, Nevada County has opted into the Drug Medi-Cal Organized Delivery System (DMC-ODS) with the Department of Health Care Services as of July 1, 2018; and

WHEREAS, pursuant to DMC-ODS, Nevada County is required to contract with an organization that provides a Narcotic Treatment Program; and

WHEREAS, the Contractor opened a medication unit in Grass Valley in May 2018 that provides a Narcotic Treatment Program; and

WHEREAS, the County entered into a renewal contract with Aegis Treatment Centers, LLC. for Nevada County DMC beneficiaries to receive Narcotic Treatment Program services locally and in neighboring counties, and enable Nevada County to be compliant with DMC-ODS requirements on August 27, 2019 per Resolution 19-472 for the contract term July 1, 2019 through June 30, 2020; and

WHEREAS, the parties desire to amend their agreement to: 1) increase the Maximum Contract Price from \$138,437 to \$300,000 (an increase of \$161,563); 2) revise Exhibit "A" Schedule of Services to reflect an update in staffing requirements, and 3) revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between Aegis Treatment Centers, LLC., for the provision of a Drug Medi-Cal (DMC) outpatient Narcotic Treatment Program (NTP) for referred clients of the Nevada County Behavioral Health Department for the contract term of July 1, 2019 through June 30, 2020, in the maximum amount of \$300,000 be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada and authorizes and directs the Auditor-Controller to release fund balance in Fund 1481 and amend Behavioral Health's budget as follows:
