

AMENDMENT TO THE UNEMPLOYMENT COMPENSATION SERVICES MODEL AGREEMENT

This Amendment ("Amendment") is by and between **County of Personnel Administrators Association of California ("CPAAC")**, **TALX Corporation ("Contractor")** and the County of Nevada ("County"); and is effective as of **May 1, 2015 ("Effective Date")**. This Amendment is entered into with the express agreement that except as addressed herein, all terms, conditions and stipulations contained in the Unemployment Compensation Services Model Agreement between CPAAC, Contractor and County with an Effective Date of May 1, 2012, and as previously amended, (the "**Agreement**") shall remain in full force and effect and without any change or modification whatsoever. For the purposes of this Amendment, all capitalized terms used herein and not otherwise defined shall have the meaning set forth in the Agreement.

WHEREAS, the parties desire to amend the Agreement, as set forth herein and hereby reaffirm and ratify each of the terms and conditions in the Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants set forth herein, and for other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as follows:

Amendment to Section 3, Terms of the Agreement



The term of the Agreement is extended through December 31, 2015.

Effect of Amendment; Entire Agreement. This Amendment together with the Agreement (and any attachments, addenda, and supplements thereto) shall be the complete and exclusive statement of the Agreement between the parties as to the subject matter of the Agreement, and shall be binding upon each of the parties hereto, their respective successors and to the extent permitted their assigns. In the event of a conflict between the terms and conditions hereof, and the terms and conditions of the Agreement, the specific terms and conditions set forth in the Amendment shall govern.

Miscellaneous; Other Terms. Neither this Amendment nor the Agreement can be amended or otherwise modified, except as agreed to in writing by each of the parties hereto.

This Amendment is accepted and agreed to by the following authorized representatives of the parties and each person signing below represents and warrants that they have the necessary authority to bind the principal set forth below.
