Dear Ben,

WELCO Underground Construction, Inc. (WELCO Underground Construction/ WELCO) hereby proposes to furnish all labor, equipment, tools supervision, insurance and other services required to provide the complete work in accordance with your scope of work and exclusions as follows:

SCOPE OF WORK

- 1 Daily Rate to bore and install ³2" drain lines on regular time.
- 2 Daily Rate to bore and install ³2" drain lines on premium time.
- 3 Price for 3" slotted drain pipe. ³

COMPLETION

Our proposal is based on compliance with a reasonable project schedule. WELCO will require that reasonable time be allowed for boring and excavation.

1. Price is based on type and duration of services listed above. Any additional services and / or materials will require additional time and / or cost.
2. Our proposal assumes that we will be provided access to the work location. Any delays due to permits or right-of-way (by others) or any other condition beyond the control of WELCO may result in additional time and/ or cost.

PROJECT SPECIFIC CLARIFICATIONS/EXCLUSIONS

1. All potholing of existing utilities to be done by WELCO.
2. Restoration to be done by others.
3. Tie ins to be done by others.
4. Bore pits to be done by others.
5. Bore spoils to be dumped by WELCO.
6. Materials to be supplied by WELCO.

6. Materials to be supplied by WELCO.
7. USA to be done by WELCO. Any fees from local agencies for locating or performing standby in compliance with USA laws are not included in this proposal.
8. WELCO is not responsible for damage to private utilities that are not marked by USA. If WELCO is requested to repair the damaged utility, cost of repair and labor will be charted at a T & M rate.
9. Traffic control, permits, fees, utility company charges, inspection or material test are not included in the above scope of work.
10. Price is based on standard work hours, 5 days per week.
11. In event of damaged utilities all USA laws will govern.

STANDARD CLARIFICATIONS/EXCLUSIONS

1. If requested prior to commencement of work, WELCO Underground Construction, Inc. can provide, at customer's expense, performance and payment bonds for this project. The bond cost is not included in the following bid amount.
2. This proposal/contract is valid 30 days net, upon receipt of this letter.
3. Payment terms are 30 days net, upon receipt of invoice.
4. Acceptance of this proposal, as indicated by the customer's request for performance, shall constitute full acceptance of all terms and conditions as herein stated. This proposal shall constitute the entire agreement between the parties, and no further contract documents shall be required for performance or payment.
5. The price quoted does not include rock or other unsuitable soil conditions which make it prohibitive for boring. In the event that the bore cannot be fully completed as a result of unsuitable conditions, customer will pay on a T & M basis for time spent.
