SUBJECT: Appointment of Sarah Holyhead as a Citizen at Large member and Erika Seward as Local Business Representative, and reappointment of Thomas Jacobs as Citizen Knowledgeable of Hazardous Waste Disposal Practices and Gary Brown as a Citizen at Large member, all to the Solid and Hazardous Waste Commission for terms ending January 31, 2022.

RECOMMENDATION: Appoint Sarah Holyhead as a Citizen at Large member and Erika Seward as Local Business Representative to the Solid and Hazardous Waste Commission to fill 2-year unexpired terms ending January 31, 2022, and reappoint Thomas Jacobs as Citizen Knowledgeable of Hazardous Waste Disposal Practices and Gary Brown as a Citizen at Large member to the same commission for 2-year terms ending January 31, 2022.

BACKGROUND:

Currently there are two vacancies on the Nevada County Solid and Hazardous Waste Commission, one for a Citizen at Large member and one for a Local Business Representative. These vacancies are to fill 2-year unexpired terms ending January 31, 2022. There are also two positions that became available on January 31, 2020, one for a Citizen Knowledgeable of Hazardous Waste Practices and one for a Citizen at Large member. These positions are for 2-year terms ending January 31, 2022. These vacancies and positions were advertised and posted for a minimum of ten days on the bulletin boards outside the Board of Supervisors Chambers, Board of Supervisors Office, Madelyn Helling Library, Grass Valley Library, Truckee Library, Truckee Joseph Center, Truckee Town Hall, the District V Board of Supervisors Office in Truckee, and on the MyNevadaCounty.com website.

Sarah Holyhead submitted an application for the Citizen at Large vacancy on November 18, 2019. She was interviewed by David Garcia, Solid Waste Program Manager, and Supervisor Susan Hoek, a Board of Supervisors member on the Commission. They have recommended Sarah Holyhead to fill the Citizen at Large vacancy.

Erika Seward submitted an application for the Business Representative vacancy on December 9, 2020. She was interviewed by David Garcia and Supervisor Hoek, as well as Trisha Tillotson, Director of Public Works. They have recommended Erika Seward to fill the Business Representative vacancy.
