

**WHEREAS**, the purpose of the election is to fill vacant offices of members of the Placer County Board of Education; and

**WHEREAS**, a statewide general election will be held within the counties of Placer, El Dorado, Nevada, and Sacramento on the same day; and

**WHEREAS**, Election Code § 10403 requires jurisdictions to file with the Board of Supervisors, and a copy with the Registrar of Voters, a resolution requesting consolidation with a statewide election; and

**WHEREAS**, it is ordered by the Board of Education that an election be held on November 3, 2020, to fill the vacant terms of the following board members whose terms will expire on the second Friday of December 2020:

**WHEREAS**, governing board seats are split into trustee areas and only those voters residing in the area may vote for candidates who run in the area; and

**WHEREAS**, the length of the Candidate Statement shall not exceed 200 words and the cost of the Candidate Statement shall be paid by the Candidate; and

**WHEREAS**, in the event of a tie vote, the election will be determined by lot; and

**WHEREAS**, the Placer County Board of Education certifies that there have been no Placer County boundary changes since the last election and that the County Board understands that the Placer County Department of Public Works Mapping Division will verify Placer County boundary lines prior to the election; and

**WHEREAS**, the Placer County Board of Education is requesting each county named in Resolution 04-2020-01 to provide the election services necessary to conduct the election; and

**NOW, BE IT RESOLVED** that the Placer County Superintendent of Schools is hereby Ordered to call an election for the purpose and in accordance with the designations contained in the Specifications of the Election Order above, and

**NOW, BE IT FURTHER RESOLVED** that the Board of Supervisors of Placer, El Dorado, Nevada, and Sacramento Counties are requested by the Placer County Board of Education to:

1. Consolidate the election with any other applicable election conducted on the same day;
2. Authorize and direct the County Clerk, at governing board expense, to provide all necessary election services to conduct the election, for the actual cost of those services.
3. In the event of a tie vote, the winning candidate shall be determined by lot.

This Resolution shall be considered a Notice of Election and Specification of the Election Order.
