



# RESOLUTION No. 26-022

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING EXECUTION OF A RENEWAL REVENUE CONTRACT FOR SERVICES WITH THE COUNTY OF PLACER FOR NEVADA COUNTY TO PROVIDE CRISIS STABILIZATION UNIT (CSU) SERVICES TO PLACER COUNTY REFERRED CLIENTS FOR THE TERM OF JANUARY 1, 2026, THROUGH JUNE 30, 2027, IN THE MAXIMUM CONTRACT AMOUNT OF \$75,000

WHEREAS, Nevada County Behavioral Health Department operates a Crisis Stabilization Unit (CSU) 24 hours per day, 7 days per week, where individuals can receive crisis services through the County's subcontractor, Sierra Mental Wellness Group, including psychotherapy and medication support for up to 23 consecutive hours per crisis event; and


WHEREAS, Placer County desires to make the most appropriate and economical use of regional services in order to provide comprehensive mental health services to residents of Placer County; and

WHEREAS, Nevada County is willing to accept Placer County referred clients deemed appropriate for admission to the CSU, including those in need of crisis stabilization services, and those on Welfare and Institution Code section 5150 holds when the CSU is determined to be the most appropriate setting for the provision of evaluation and crisis intervention services to either resolve the need for the 5150 hold within the 23-hour period or, if unable to do so, facilitate placement in an acute psychiatric hospital setting; and

WHEREAS, the Counties of Placer and Nevada wish to enter into this mutually beneficial agreement whereby Nevada County Behavioral Health is agreeing to provide Crisis Stabilization Services through its subcontractor to Placer County referred clients, and Placer County shall reimburse Nevada County Behavioral Health, providing revenue to offset CSU operational costs and promoting the mutual working relationship between Placer and Nevada Counties.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Contract by and between the County of Nevada, Department of Behavioral Health and the County of Placer, pertaining to Nevada County providing CSU Services through its subcontractor, Sierra Mental Wellness Group, for Placer County referred clients for a total contractual obligation not to exceed \$75,000 for the term of January 1, 2026, through June 30, 2027, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Contract on behalf of the County of Nevada.
