RESOLUTION APPROVING AN APPLICATION FOR CALIFORNIA DEVELOPMENT BLOCK GRANT DISASTER RELIEF MITIGATION RESILIENCE PROGRAM FUNDING AND THE EXECUTION OF A STANDARD AGREEMENT AND ANY AMENDMENTS THERETO, AND CERTAIN RELATED LOAN OR GRANT DOCUMENTS AND ANY AMENDMENTS THERETO, RELATED TO ANY AWARD MADE PURSUANT TO SUCH APPLICATION – DISTRICT IV

BE IT RESOLVED by the Board of Supervisors, the “Governing Body,” of the County of Nevada, the “Applicant,” as follows:

SECTION 1:

The Governing Body has reviewed and hereby approved the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$5,659,981.00, as it related to any California Development Block Grant Disaster Relief Mitigation-Resilience Program award issued from the California Department of Housing and Community Development (the “Department”).

SECTION 2:

The Applicant acknowledges compliance with all state and federal public participation requirements in the development of its application(s).

SECTION 3:

The Governing Body hereby authorizes and directs the Director of Public Works (the “Application Authorized Signer”), or Designee, Community Development Agency Director (the “Application Designated Signer”) to execute and deliver all applications and act on the Applicant’s behalf in matters pertaining to all such applications.

SECTION 4:

If an application is approved, the Governing Body hereby authorizes and directs the Director of Public Works (the “Application Authorized Signer”), or Designee, Community Development Agency Director (the “Application Designated Signer”) to enter into, execute and deliver any and all agreements deemed necessary or appropriate by the Department, including but not limited to the Department’s Standard Agreement and any amendments thereto, and any and all other documents necessary or appropriate to evidence or secure the funding to be received by Applicant, and any and all subsequent amendments thereto (collectively, the “Award Documents”).

SECTION 5:

If an application is approved, the Governing Body hereby authorizes and directs the Director of Public Works (“Funds Request Signer”), or Designee, Community Development Agency Director (the “Funds Request Designated Signer”) to sign and submit Funds Requests

and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
