BACKGROUND:

Currently, there are five positions available July 1, 2024 for the Local Planning Council for Child Care Development for the County of Nevada. One Child Care Provider, one Community Member, two Consumer Member, and one Chair of the Board of Supervisors Public Agency representative, all to fill two-year terms beginning July 1, 2024 and ending June 30, 2026. These positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Justine Riley submitted an application for reappointment to the Child Care Coordinating Council on May 30, 2024. Justine Riley has served on the Council since September 13, 2016.

Sandra Boone submitted an application for reappointment as Community Member on June 8, 2024. Sandra Boone has served on the Council since January 6, 1998.

Lauren Garrison submitted an application for reappointment as Consumer Member on June 11, 2024. Lauren Garrison has served on the Council since November 8, 2016.

Anne Wolf submitted an application for reappointment as Discretionary Member on June 11, 2024. Anne Wolf has served on the Council since August 11, 2015.

Carolyn Tate submitted an application for reappointment as Child Care Provider Member on June 10, 2024. Carolyn has served on the Council since July 1, 2009.

All members are in good standing and are recommended by the Local Planning Council for Child Care Development for the County of Nevada for reappointment.
