## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION REQUESTING THE NEVADA COUNTY TRANSPORTATION COMMISSION ALLOCATE \$1,757,957 FROM LOCAL TRANSPORTATION FUNDS (LTF) AND \$379,190 FROM STATE TRANSIT ASSISTANCE FUNDS (STA) FOR OPERATION OF THE GOLD COUNTRY STAGE TRANSIT SERVICES AND PARATRANSIT SERVICES AND ALLOCATE \$100,000 FROM COMMUNITY TRANSIT SERVICES (CTS) FUNDS FOR OPERATIONAL SUPPORT OF CONTRACTED PARATRANSIT SERVICES FOR FISCAL YEAR 2016/17

WHEREAS, the Nevada County Transportation Commission is the Regional Transportation Planning Agency for Nevada County; and


WHEREAS, the Nevada County Regional Transportation Plan and the Western Nevada County Transit Development Plan recognize the continuing need in western Nevada County for transit and paratransit services; and

WHEREAS, the Nevada County Department of Public Works Transit Services Division is the operator of the Gold Country Stage public fixed-route transit system, and contracts with Paratransit Services for the provision of demand-responsive paratransit services; and

WHEREAS, in accordance with the State of California Transportation Development Act and the policies and procedures of the Nevada County Transportation Commission, a claim for the operation of western Nevada County transit and paratransit services in Fiscal Year 2016/17 is submitted by the Nevada County Board of Supervisors for consideration by the Nevada County Transportation Commission.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Requests that the Nevada County Transportation Commission allocate the sum of \$1,757,957 from Nevada County's apportionment of Local Transportation Funds (LTF) and \$379,190 from Nevada County's apportionment of State Transit Assistance (STA) funds for operation of transit and paratransit services in Fiscal Year 2016/17.
- 2. Requests that the Nevada County Transportation Commission allocate the sum of \$100,000 of Community Transit Services (CTS) funds for operational support of paratransit services provided by Paratransit Services under contract with Nevada County for Fiscal Year 2016/17.
- 3. Directs the Auditor-Controller to deposit the LTF and CTS funds when received into fund 4281-91003-707-1000/401500 and to deposit the STA funds when received into fund 4281-91003-707-1000/440170.
