## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE RENEWAL PERSONAL SERVICES CONTRACT WITH COMMUNITY RECOVERY RESOURCES (CoRR) (RESOLUTION 17-449) AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH DEPARTMENT'S BUDGET FOR FISCAL YEAR 2017/18 (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, Community Recovery Resources (CoRR) is a non-profit organization licensed by the State to provide services for the prevention, treatment and recovery of alcohol and drug dependency; and

WHEREAS, per Resolution 17-449, the Nevada County Board of Supervisors approved the renewal contract with Community Recovery Resources (CoRR) to provide Perinatal Outpatient Drug Free (ODF) Treatment Program Services and Intensive Outpatient Treatment (IOT) Services for substance using pregnant and/or parenting women; Comprehensive Residential Treatment Program Services for the recovery of alcohol/drug dependency; and Substance Abuse Prevention and Treatment Services, to residents of Nevada County; and

WHEREAS, the Parties wish to amend their Agreement to increase the maximum contract price due to an unanticipated increase in services and amend Exhibit "B", "Schedule of Charges and Payments" to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County and Community Recovery Resources for the provision of Perinatal Outpatient Drug Free (ODF) Treatment and Intensive Outpatient Treatment (IOT) Services for substance using pregnant and/or parenting women; Comprehensive Residential Treatment Program Services for the recovery of alcohol/drug dependency; and Substance Abuse Prevention and Treatment Services, to residents of Nevada County, pertaining to increasing the maximum contract price from \$539,074 to \$653,284 (an increase of \$114,210) for Fiscal Year 2017/18 and amending Exhibit "B", "Schedule of Charges and Payments" to reflect the increase in the maximum contract price, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes and directs the Auditor-Controller to amend the Behavioral Health Department's Budget for Fiscal Year 2017/18 as follows:
