OF VOTERS**


WHEREAS, California Elections Code § 15372 requires the Nevada County Clerk-Recorder/Registrar of Voters to prepare a certified statement of election results within the County and submit it to the Board of Supervisors; and

WHEREAS, the Nevada County Clerk-Recorder/Registrar of Voters did canvass the returns of the November 4, 2025, Statewide Special Election, and has certified the results of the votes cast at said election, which are attached as Exhibit A and incorporated by reference; and

WHEREAS, California Elections Code § 15400 provides that the Board of Supervisors shall declare elected to each office voted on at each election under its jurisdiction the person who receives a majority of all ballots cast for candidates for that office and/or ballots cast for each Measure under its jurisdiction as reflected in Exhibit A, attached hereto and incorporated by this reference.

NOW, THEREFORE, BE IT HEREBY RESOLVED that Nevada County Board of Supervisors hereby adopts the certified statement of votes cast at the Statewide Special Election on November 4, 2025, with the County of Nevada as certified by the County Clerk-Recorder/Registrar of Voters as reflected in Exhibit A, with the following results:


