**BACKGROUND:**

Currently, there are two positions available on the Agricultural Advisory Commission for four-year terms ending March 31, 2026. One Farming Industry Representative position becoming available April 1, 2022, for a four-year term ending March 31, 2026. One Cattle Industry Representative position becoming available April 1, 2022, for a four-year term ending March 31, 2026. These vacancies and positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.
