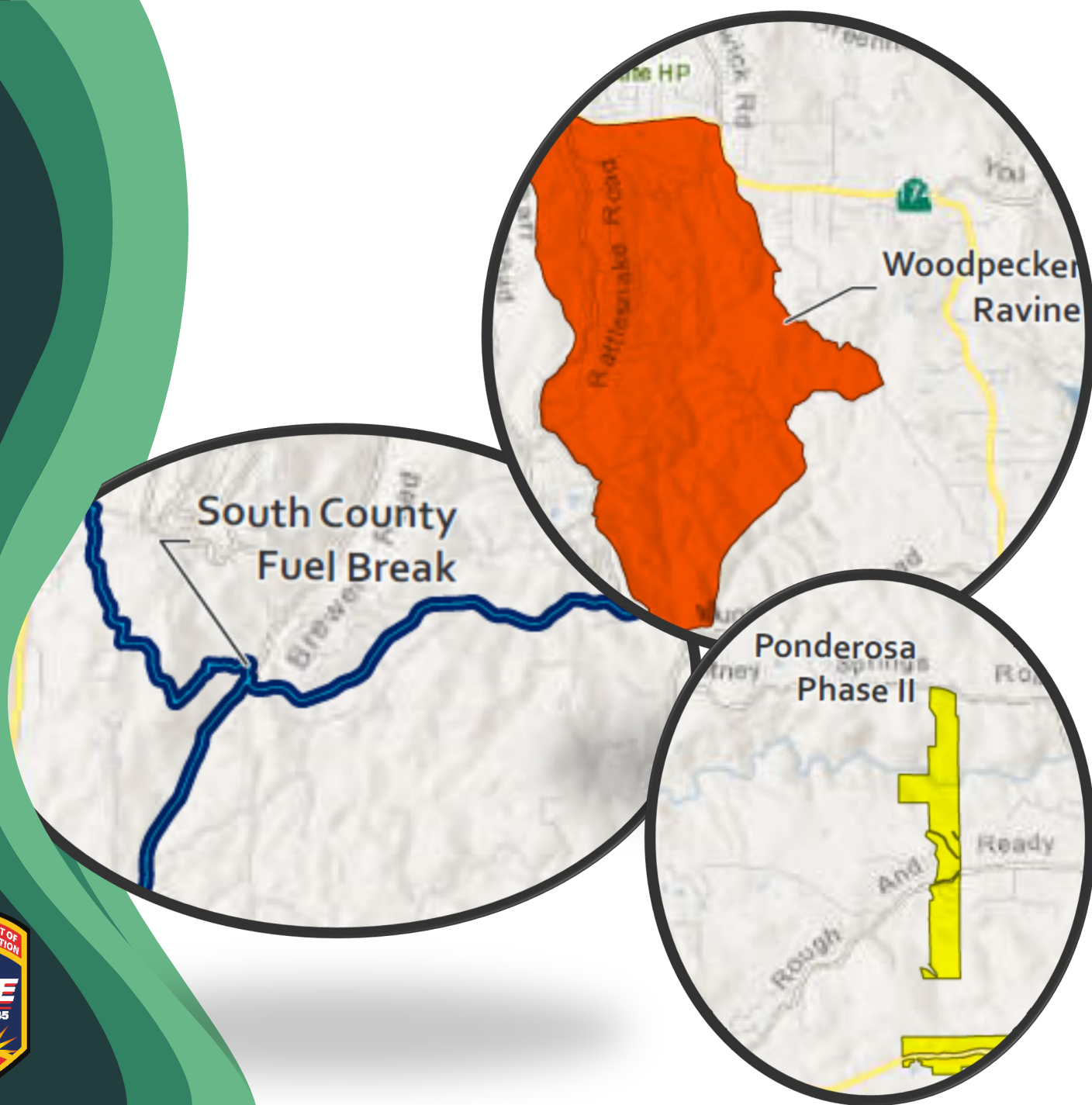

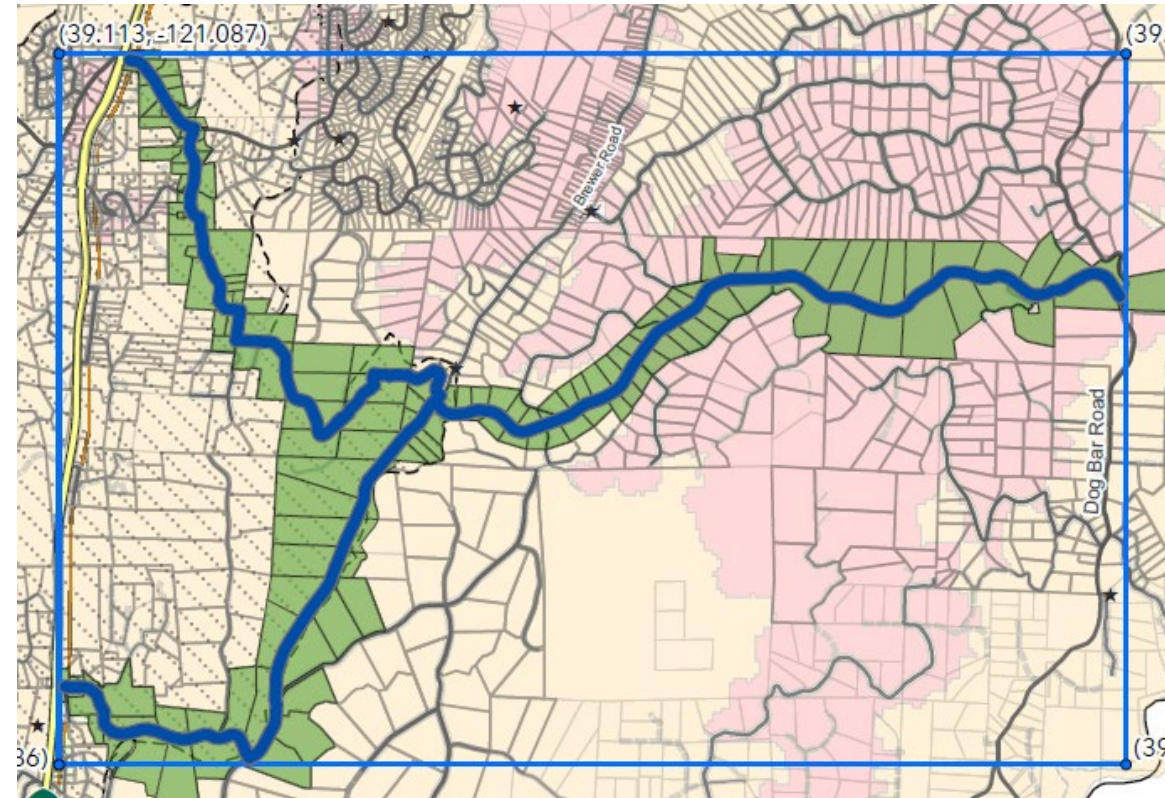


Projects/Contracts

- **Contract with Fire Safe Council of Nevada County for South County Shaded Fuel Break**
- **USDA grant acceptance for the Ponderosa West Grass Valley Defense Zone Phase 2 Project**
- **CAL FIRE grant acceptance for the Woodpecker Ravine Shaded Fuel Break Project**
- **USDA grant application for Community Wildfire Protection Plan (CWPP) update funding**

South County Shaded Fuel Break

- CAL FIRE Grant Application – March 1, 2021
- A top priority project in the CAL FIRE Unit Plan
- 339-acre project area – 226 private parcels
- \$901,578 – with \$85,620 match
- 150ft wide treatment area east-west on Lodestar Road to Buck Mountain
- Reduce fire intensity, stronghold for first responders and safer ingress/egress

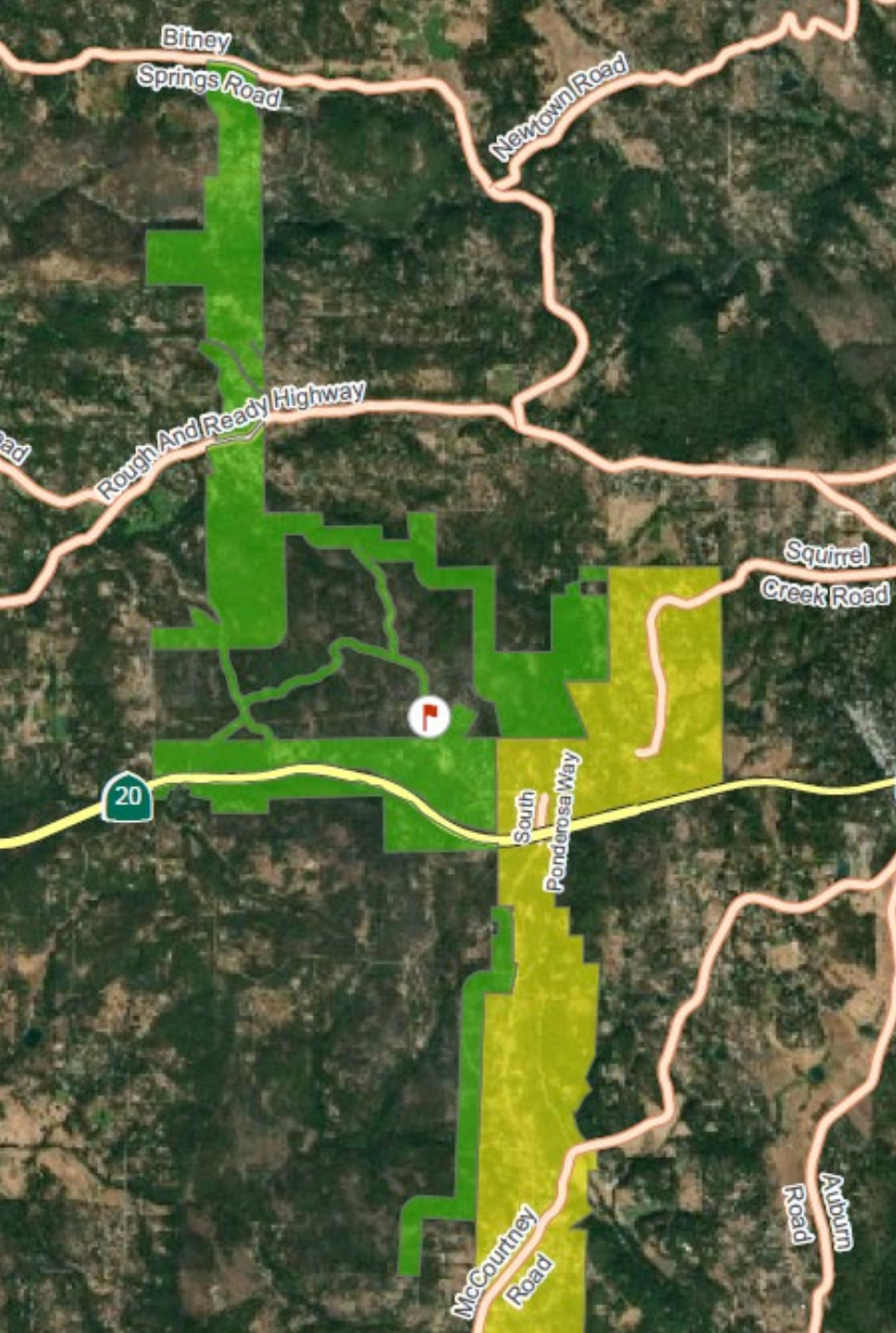
South County Shaded Fuel Break

- **Timeline: September 2022 – December 2024**
- **Project Tasks:**
 - Outreach
 - Property owner engagement
 - Match provision/engagement
 - Implementation
 - Grant deliverable management
- **Treatment methods/approach**

Ponderosa West Grass Valley Defense Zone Phase 2

- **Grant application – April 23, 2021**
- **Grant acceptance - \$750,000**
- **\$772,282 match required**
- **FY22 Federal Earmark Opportunities – Appropriations Fund**
- **Timeline: Sep. 2022 – Sep. 2024**
- **Priority:**
 - Local Hazard Mitigation Plan
 - CAL FIRE Unit 2021 Strategic Plan
 - Community Wildfire Protection Plan

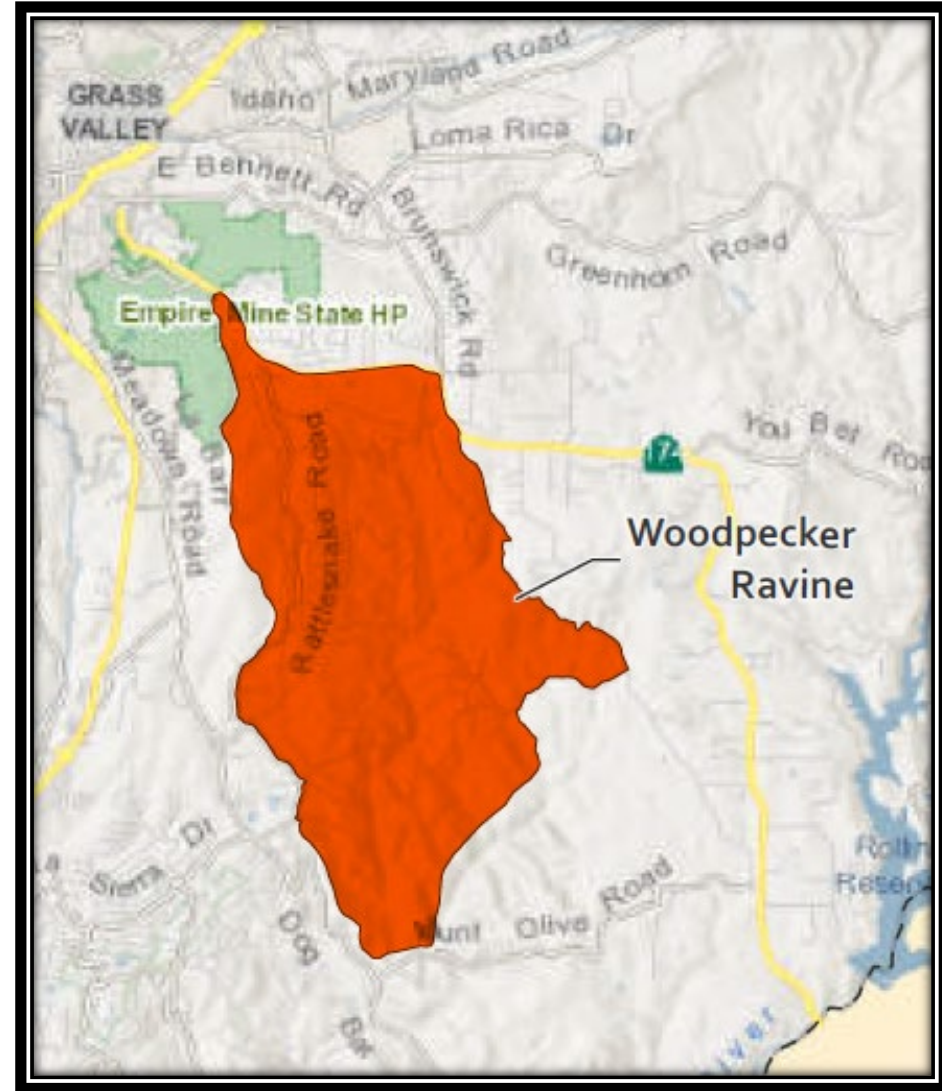


Ponderosa West Grass Valley Defense Zone Phase 2

- 300-acre treatment area on private property
- Extension to Phase 1
- Bounded by Hwy 20 to South & Bitney Springs Road to the North
- Creates defense zones around homes and improves ingress/egress safety
- Protection for Grass Valley, Penn Valley, Rough and Ready and Alta Sierra Communities

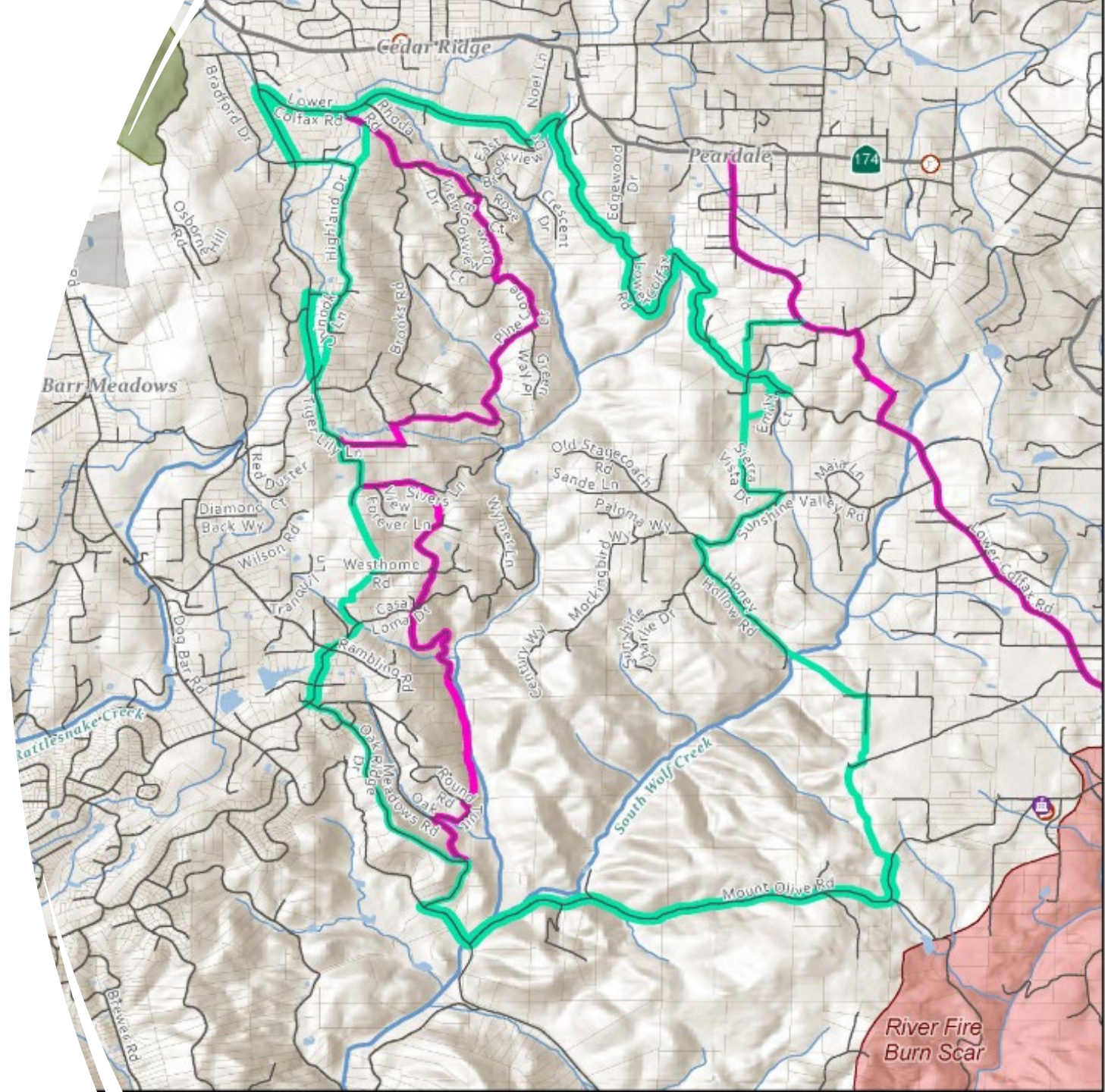
Woodpecker Ravine Shaded Fuel Break

- CAL FIRE Grant application – February 9, 2022
- Grant acceptance - \$2,178,004
- CAL FIRE CA Climate Investments Fire Prevention Grant program
- Timeline: Sep. 2022 – March 2026
- CAL FIRE Unit 2021 Strategic Plan Priority
- BRIC Grant Match



Woodpecker Ravine Shaded Fuel Break

- 410-acre treatment area
- Flanked by Hwy 49 & Hwy 174 key evacuation corridors
- Remove hazardous vegetation from critical primary & secondary evacuation routes and ridgelines
- Reduce fire intensity, stronghold for first responders and safer ingress/egress



Community Wildfire Defense Grant

- **USDA FY22 Community Wildfire Defense Grant (CWDG) opportunity**
- **Grant amount: \$225,000**
- **Match required: \$25,000**
- **Help fund update to the Community Wildfire Protection Plan (CWPP) – last updated in 2016**
- **Community Wildfire Coordinator also supporting this work/update**

Washington County Water District Agreement

- **Contract grant amount: \$8,000**
- **Term: July 1, 2022 – June 30, 2023**
- **To support the Washington Fire Department. Response for :**
 - **Fire**
 - **Accidents**
 - **Medical aid**
 - **Public assistance, AND**
 - **Other public service activities**
