## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING AMENDMENT NO. 2 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND R & B COM INC, INCREASING THE CONTRACT AMOUNT BY \$15,000 FOR A MAXIMUM CONTRACT PRICE OF \$40,000 AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

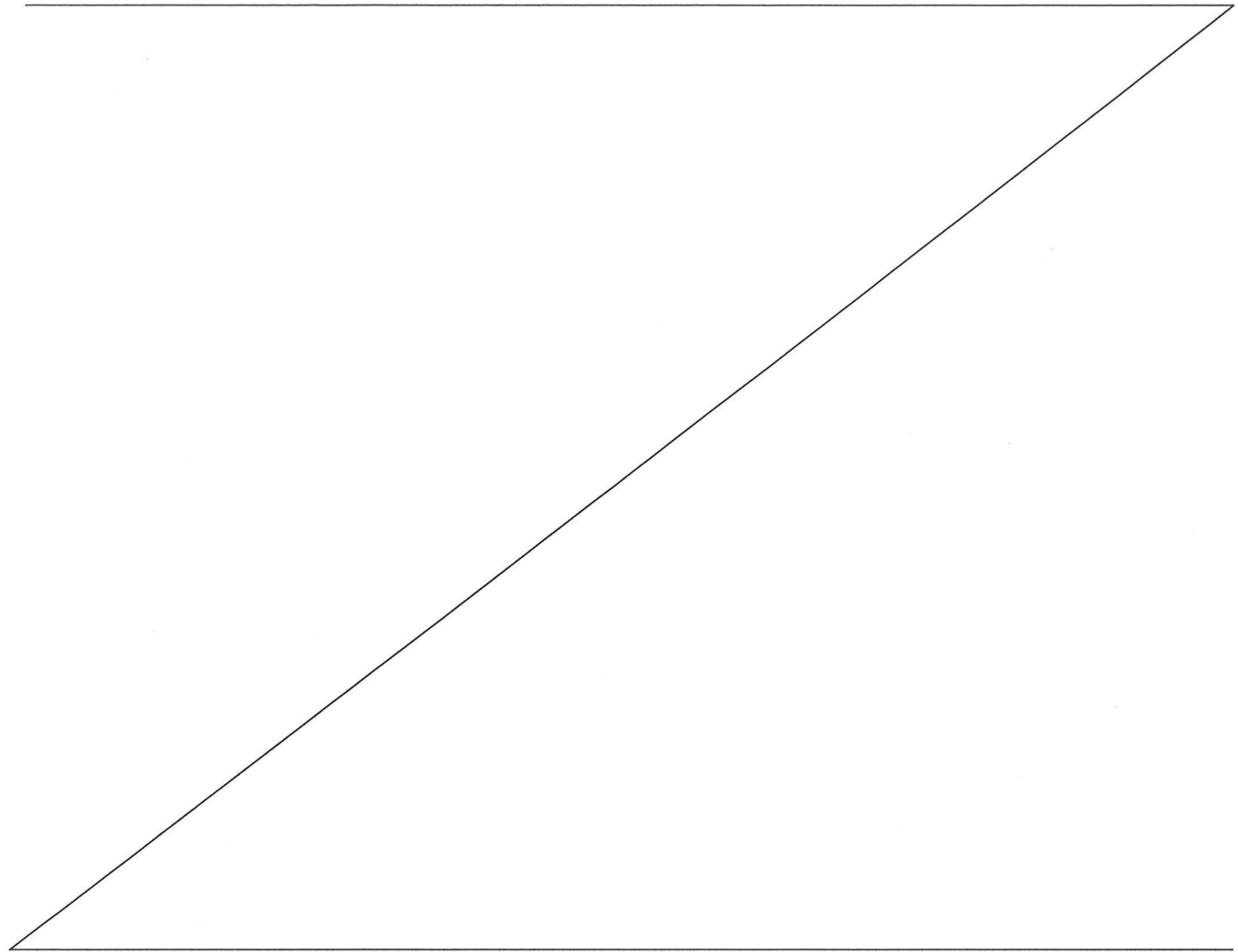
WHEREAS, on January 2, 2018, the Purchasing Agent executed a Personal Services Contract PESL3488 with R & B COM Inc., for PC Installation & Upgrade services at Nevada County Facilities in the amount of \$25,000; and

WHEREAS, there has been an increase in demand for PC installation and upgrades for county computers and additional funding is necessary to pay for these services; and

WHEREAS, funding for these additional services will be paid out of the Fiscal Year 2017-18 Information Systems budget and a budget amendment is not required.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

1. The Board approves and the Board Chair is authorized to execute Amendment No. 2 to the Personal Services Contract by and between the County of Nevada and R & B Com Inc. for PC Installation & Upgrade Services.
2. The Maximum Contract Price of \$25,000 is increased by \$15,000 to \$40,000.
3. In all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
4. The Auditor-Controller is directed to encumber the balance of the contract as amended to Information Systems 0101-11007-531-7000/521520

**AMENDMENT NO. 2 TO CONTRACT PESL3488  
WITH R & B COM INC.**

**THIS AMENDMENT** is executed this 10th day of July, 2018 by and between R & B Com Inc., (herein "Contractor") and COUNTY OF NEVADA (herein "County"). Said Amendment will amend the prior agreement between the parties entitled "PC Installation and Upgrade Services" executed on January 2, 2018.

**WHEREAS**, the contract was executed between the County and Contractor to provide PC Installation and Upgrade Services at Nevada County facilities for the period January 2, 2018 through June 30, 2018; and

**WHEREAS**, the parties desire to amend their agreement to allow for additional PC Installation and Upgrade services in the amount of \$15,000.

**NOW THEREFORE**, the parties hereto agree as follows:

1. That this amendment shall be effective as of July 10, 2018.
2. That Section 2 is amended to increase the Maximum Contract Price by \$15,000 to \$40,000.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.


