



# RESOLUTION No. 20-258

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING CONTRACT AMENDMENT NO. 3 WITH WEST COAST ARBORISTS, INC., FOR TREE TRIMMING AND REMOVAL SERVICES

WHEREAS, the Nevada County Board of Supervisors (Board) approved Resolution 17-529 approving a contract with West Coast Arborists, Inc., (WCA) for tree trimming and removal services with the ability to execute four (4) additional annual renewals beginning July 1, 2019; and

WHEREAS, the Board approved Resolution 19-281 approving Amendment No. 1 to the contract for \$150,000 effective July 1, 2019 through June 30, 2020; and

WHEREAS, the Board approved Resolution 19-387 approving Amendment No. 2 to allow for an updated Exhibit B: Schedule of Charges and Payments to allow for increases in the California Department of Industrial Relations pre-determined wages; and

WHEREAS, the Department recommends approving Amendment No. 3 with West Coast Arborists Inc., for an additional one-year term of July 1, 2020 through June 30, 2021, with a not-to-exceed contract amount of \$150,000; and

WHEREAS, Fiscal Year 2020/21 has sufficient budget in 1114-30107-703-1000/521520 to encumber the contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves Amendment No. 3 to the contract, attached as Exhibit A, and authorizes the Chair of the Board of Supervisors to execute the Amendment between the County of Nevada and West Coast Arborists, Inc., for tree trimming and removal services in the annual amount of \$150,000.

**AMENDMENT 3 TO CONTRACT WITH WEST COAST ARBORISTS, INC.**

**THIS AMENDMENT** is executed this 23rd day of June, 2020 by and between West Coast Arborists, Inc., and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Tree Trimming and Removal Services executed on October 20, 2017, by Resolution No. 17-529 and which Agreement was subsequently amended on June 18, 2019, by Resolution No. 19-281 (Amendment 1) and amended on July 9, 2019, by Resolution No. 19-387 (Amendment 2).

**WHEREAS**, the parties desire to amend their agreement to allow or provide for an annual renewal effective July 1, 2020, through June 30, 2021; and

**WHEREAS**, this annual renewal will be for \$150,000.

**NOW, THEREFORE**, the parties hereto agree as follows:

1. This amendment shall be effective as of July 1, 2020.
2. That paragraph 3 shall be changed to the following:

**Contract Beginning Date:** 7/1/2020      **Contract Termination Date:** 6/30/2021

3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
