# OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AUTHORIZING THE PURCHASE OF A RADIO REPEATER AS A CAPITAL ASSET FOR THE WAYNE BROWN CORRECTIONAL FACILITY AT \$6,714.27 AND AUTHORIZING A BUDGET AMENDMENT TO FUND THE PURCHASE OF THE CAPITAL ASSET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Nevada County Sheriff's Office desires to maintain the safety and wellbeing of the Incarcerated Persons and Correctional Officers at the Wayne Brown Correctional Facility; and

WHEREAS, the current radio repeater, which relays radio transmissions among correctional staff, has reached the end of its useful life; and

WHEREAS, new quotes were requested for a replacement radio repeater. An FM Analog/NXDN/DMR Repeater and ancillary equipment to be installed by Banner Communications was determined to be the best suited for the jail facility.

NOW, THEREFORE, BE IT RESOLVED the Nevada County Board of Supervisors, on behalf of the County of Nevada authorizes:

- 1) The above recitals are true and correct; and
- 2) Authorizes the Sheriff's Office to purchase a radio repeater and ancillary equipment in the amount of \$6,714.27 including installation; and
- 3) Direct the Auditor/Controller to amend the Sheriff's Office Fiscal Year 2024/25 budget as follows:

The WBCF current radio repeater is 20 years old and parts are becoming obsolete. Further, the manufacturer has ceased any system updates or technological support for the current device.
