

RESOLUTION No. 19-625

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION CONSOLIDATING THE CITY OF NEVADA CITY GENERAL MUNICIPAL ELECTION, PENN VALLEY UNION ELEMENTARY SCHOOL DISTRICT ELECTION, AND THE HIGGINS FIRE PROTECTION DISTRICT ELECTION, WITH THE PRESIDENTIAL PRIMARY ELECTION TO BE HELD IN THE COUNTY OF NEVADA, IN THE STATE OF CALIFORNIA, ON TUESDAY, MARCH 3, 2020

WHEREAS, the City of Nevada City has four elective offices that are to be filled at their General Municipal Election and has requested said election be consolidated with the Presidential Primary Election to be held in the County of Nevada on March 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary to conduct the election, and states that the City will reimburse the County for their prorated share of the cost of the election for each voter registered on the 15th day prior to election; and


WHEREAS, the Penn Valley Union Elementary School District has called for the submission of a bond measure to the voters, and hereby requests said measure be consolidated with the Presidential Primary Election to be held in the County of Nevada on March 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary to conduct the election for each voter registered in the district on the 15th day prior to election day in each section of the County for which there appears on the ballot measure for that district; and

WHEREAS, the Higgins Fire Protection District has called for the submission of a special tax measure to the voters, and hereby requests said measure be consolidated with the Presidential Primary Election to be held in the County of Nevada on March 3, 2020, authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render all services necessary to conduct the election for each voter registered in the district on the 15th day prior to election day in each section of the County for which there appears on the ballot measure for that district; and

WHEREAS, Elections Code Sections 10400, 10401, 10402 and 10403 provide that the County Board of Supervisors may order the consolidation of any election called for the submission of a question, proposition, or office.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that: the City of Nevada City general municipal election, Penn Valley Union Elementary School District bond measure, and Higgins Fire Protection District special tax measure shall be consolidated with the Presidential Primary Election to be held in the County of Nevada on Tuesday, March 3, 2020.

BE IT FURTHER RESOLVED, that the Nevada County Clerk-Recorder/Registrar of Voters shall be and is hereby authorized and directed to render all services necessary for the conduct of said elections.
