
WHEREAS, per resolution 15-538, the Board of Supervisors approved the contract with Northwest Professional Consortium for the contract term of January 1, 2016 through September 30, 2016 for the provision of evaluation services, policy analysis, research and training pertaining to collaborative criminal courts and treatment practices; and

WHEREAS, the parties desire to amend their Agreement to extend the contract termination date from September 30, 2016 to December 31, 2016.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County of Nevada and Northwest Professional Consortium, Inc. pertaining to extending the contract termination date from September 30, 2016 to December 31, 2016 for the provision of evaluation services, policy analysis, research and training pertaining to collaborative criminal courts and treatment practices in the maximum amount of \$32,000, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada

BE IT FURTHER RESOLVED, that the Nevada County Board of Supervisors hereby directs the Auditor-Controller to encumber \$16,007 for Fiscal Year 2016/2017.
