RESOLUTION ACCEPTING THE CALIFORNIA OFFICE OF EMERGENCY SERVICES GRANT AWARD VV24022601 FOR THE NEVADA COUNTY DISTRICT ATTORNEY'S OFFICE FOR THE VIOLENCE AGAINST WOMEN VERTICAL PROSECUTION PROGRAM IN THE AMOUNT OF \$202,545 FOR THE PERIOD OF JANUARY 1, 2025, THROUGH DECEMBER 31, 2025, AND AUTHORIZING THE DISTRICT ATTORNEY, OR THEIR ASSIGNEE, TO EXECUTE THE GRANT AGREEMENT AND ALL ADDITIONAL DOCUMENTS TO FULFILL THE GRANT REQUIREMENTS AND APPROVING A BUDGET AMENDMENT (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the California Office of Emergency Services (Cal OES) has awarded the County of Nevada District Attorney's Office Federal Services Training Officers Prosecutors (STOP) Grant funds; and

WHEREAS, the Cal OES grant award is comprised of Federal STOP funds in the amount of \$202,545 and have been made available for the grant period of January 1, 2025 to December 31, 2025; and

WHEREAS, these funds will be used to provide victim-centered prosecution to address violent crimes against women, and enhance victim services involving violent crimes against women in Nevada County.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby accepts the California Office of Emergency Services grant for the Nevada County District Attorney's Office in the amount of \$202,545, for the grant period of January 1, 2025, through December 31, 2025; the District Attorney, or their designee, is authorized to execute any additional documents, including extensions or amendments thereto, required by Cal OES and necessary for implementation of this grant award; and

BE IT FURTHER RESOLVED that the Auditor-Controller is authorized to amend the Fiscal year 2024/25 budget, increasing the following revenue and expenditure accounts:
