RESOLUTION ACCEPTING THE DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL (ABC) ALCOHOL POLICING PARTNERSHIP (APP) GRANT IN THE AMOUNT OF \$76,362.00 FOR FISCAL YEAR 2024/25 AND FOR COSTS ASSOCIATED WITH MONITORING COMPLIANCE OF ABC LIQUOR LICENSE HOLDERS AND UNDERAGE DRINKING, APPROVING THE AGREEMENT, AND AUTHORIZING THE SHERIFF TO EXECUTE THE AGREEMENT

WHEREAS, the Nevada County Sheriff's Office received notification on May 18, 2024, that Nevada County was selected to receive APP Grant funding in the amount of \$76,362.00 for fiscal year 2024/25; and

WHEREAS, the Department of Alcoholic Beverage Control APP grant will provide funding to aid the Sheriff's Office in the prevention and illegal use of alcohol by minors, as well as other illegal alcohol related activities; and

WHEREAS, the project period is from July 1, 2024, to June 30, 2025, during which time the Sheriff's Office expects to receive and expend the funds; and


WHEREAS, it is agreed as a condition of this Agreement, that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and authorizing agency. The State of California and ABC disclaim responsibility for such liability; and

WHEREAS, it is agreed that no funding received per this Agreement will be used to supplant expenditures controlled by this body and that this award is not subject to local hiring freezes.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors:

- 1. Accepts the APP Grant in the amount of \$76,362.00 from the Department of Alcoholic Beverage Control, to fund expenses related to special enforcement by Nevada County Sheriff's Office regarding illegal use of alcohol by minors, persons furnishing alcohol to minors, or violations of alcohol related laws; and
- 2. Authorizes the Sheriff of the County of Nevada to execute the award Agreement, including any extensions or amendments thereof and any subsequent contract with the State in relation thereto; and
- 3. Authorizes the Sheriff, or her designee, to sign all claims and reports related to this Agreement.
