**SUBJECT:** Resolution approving execution of Program Supplement No. 00000A551 to Administering Agency-State Agreement NO. 03-5917S21 in the amount of \$116,696 for bridge repairs located at Mooney Flat Rd at Deer Creek, Mooney Flat Rd at Schmidt Creek, McCourtney Rd at Dry Creek, Purdon Rd at South Yuba River, Wolf Creek Rd at South Wolf Creek – Districts I, II, IV

**RECOMMENDATION:** Approve the attached Resolution.

**FUNDING:** Partial funding is provided by the State Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) Program. Project cost is estimated at \$185,000. State funding is \$116,696 and Road Fund will cover the \$68,304 of additional estimated costs. There is no impact to the General Fund.

**BACKGROUND:**

The County of Nevada has been allocated a total of \$116,696 in CRRSAA funds that need to be coupled with an additional \$68,304 in local funding match for a total agreement amount of \$185,000 for bridge repairs on Mooney Flat Rd at Deer Creek, Mooney Flat Rd at Schmidt Creek, McCourtney Rd at Dry Creek, Purdon Rd at South Yuba River, and Wolf Creek Rd at South Wolf Creek. The State has prepared Program Supplement Number 00000A551 which provides reimbursement guidelines and stipulations which must be followed in order for costs to be eligible for reimbursement.

In order to obtain the \$116,696, the County has programmed an additional \$68,304 of Road Funds for the local match requirement. The attached copy of Program Supplement Number 00000A551 must be approved and executed by the Board of Supervisors.
