OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 2 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND DISABILITY ACCESS CONSULTANTS (DAC) FOR THE NEVADA COUNTY FACILITIES ADA SELF EVALUATION AND TRANSITION PLAN (RES 18-504), TO EXTEND THE TERM OF THE CONTRACT FOR THE PERIOD OCTOBER 9, 2018 THROUGH SEPTEMBER 30, 2019 TO JUNE 30, 2020, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, Resolution 18-196 authorized the Purchasing Agent to issue a Request for Qualifications (RFQ) for the Nevada County Facilities ADA Self Evaluation and Transition Plan; and

WHEREAS, Resolution 18-504 awarded the contract to Disability Access Consultants, of Oroville, California, in the amount of \$60,000 that included an allowance of \$5,000; and

WHEREAS, additional County facilities, sidewalks, paths, and 239 County Bus Stops were identified as needing assessments and added to the existing survey through Resolution 19-122 that increased the maximum contract price to \$78,950 and amended the scope of work; and

WHEREAS, the contract term expires on September 30, 2019 and this amendment will extend the term of the contract to June 30, 2020 to allow for additional time to complete the survey and to allow for further assessments if required; and

WHEREAS, this survey is budgeted and paid out of the Facilities Management budget and a budget amendment is not required.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

- 1. The Board approves and the Board Chair is authorized to execute Amendment No. 2 to the Personal Services Contract by and between the County of Nevada and Disability Access Consultants for the Nevada County Facilities ADA and Self Evaluation and Transition Plan.
- 2. The Contract Termination Date of September 30, 2019 is amended to extend the term of the contract to June 30, 2020 for a new contract term of October 9, 2018 through June 30, 2020.
- 3. In all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

AMENDMENT NO. 2 TO CONTRACT BMS18504 WITH DISABILITY ACCESS CONSULTANTS

THIS AMENDMENT is executed this 24th day of September, 2019 by and between Disability Access Consultants, (herein "Contractor") and COUNTY OF NEVADA (herein "County"). Said Amendment will amend the prior agreement between the parties entitled "Nevada County Facilities ADA Self Evaluation and Transition Plan" through Resolution 18-504 executed on October 25, 2018 and subsequently amended on March 26, 2019 through Resolution 19-122.

WHEREAS, the contract was executed between the County and Contractor to provide an accessibility survey in accordance with Title II of the Americans with Disabilities Act (ADA) at various Nevada County Facilities for the period October 9, 2018 through September 30, 2019; and

WHEREAS, Amendment No. 1 amended the scope of work to include additional County facilities, sidewalks, paths, and 239 County Bus Stops identified as needing assessments; and,

WHEREAS, the parties desire to amend their agreement to provide for additional time to complete the survey and to allow for additional assessments if required.

NOW THEREFORE, the parties hereto agree as follows:

- 1. That this amendment shall be effective as of September 24, 2019.
- 2. That page 1, Section 3 "**Contract Termination Date**" be amended to June 30, 2020 for a new contract term of October 9, 2018 through June 30, 2020.
- 3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
