WHEREAS, the County of Nevada entered into Contract No. 450008 with Intermountain Slurry Seal Inc., on June 8, 2021, by Resolution 21-191 for a contract totaling \$ 757,757.00 plus a 10% contingency of \$75,775.70 for the contract work items, for a maximum not to exceed amount of \$833,532.70; and

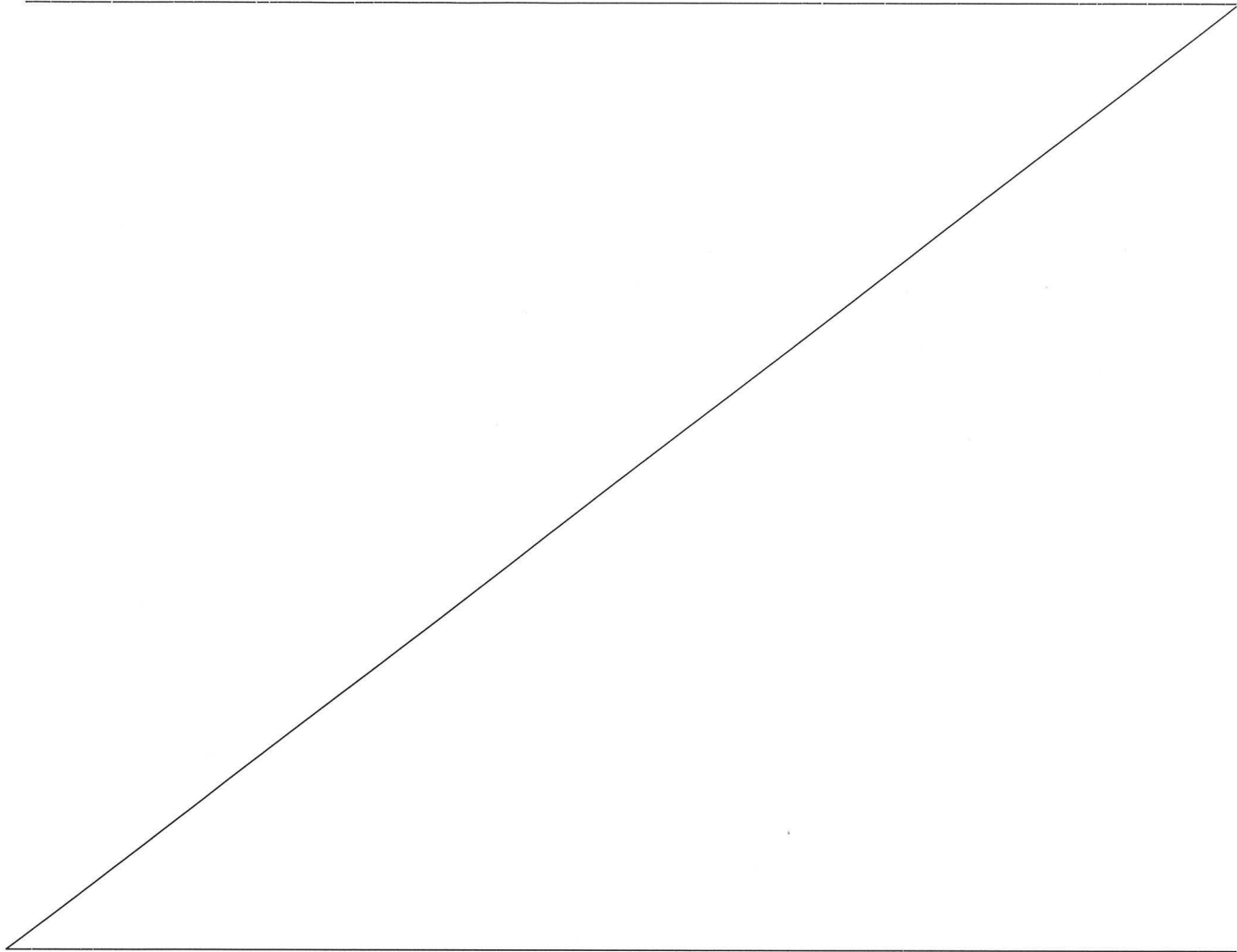
WHEREAS, said Contract was for the 2021 Road Rehabilitation Project and was constructed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of the Nevada County Department of Public Works on September 30, 2021, with contract costs totaling \$781,498.21

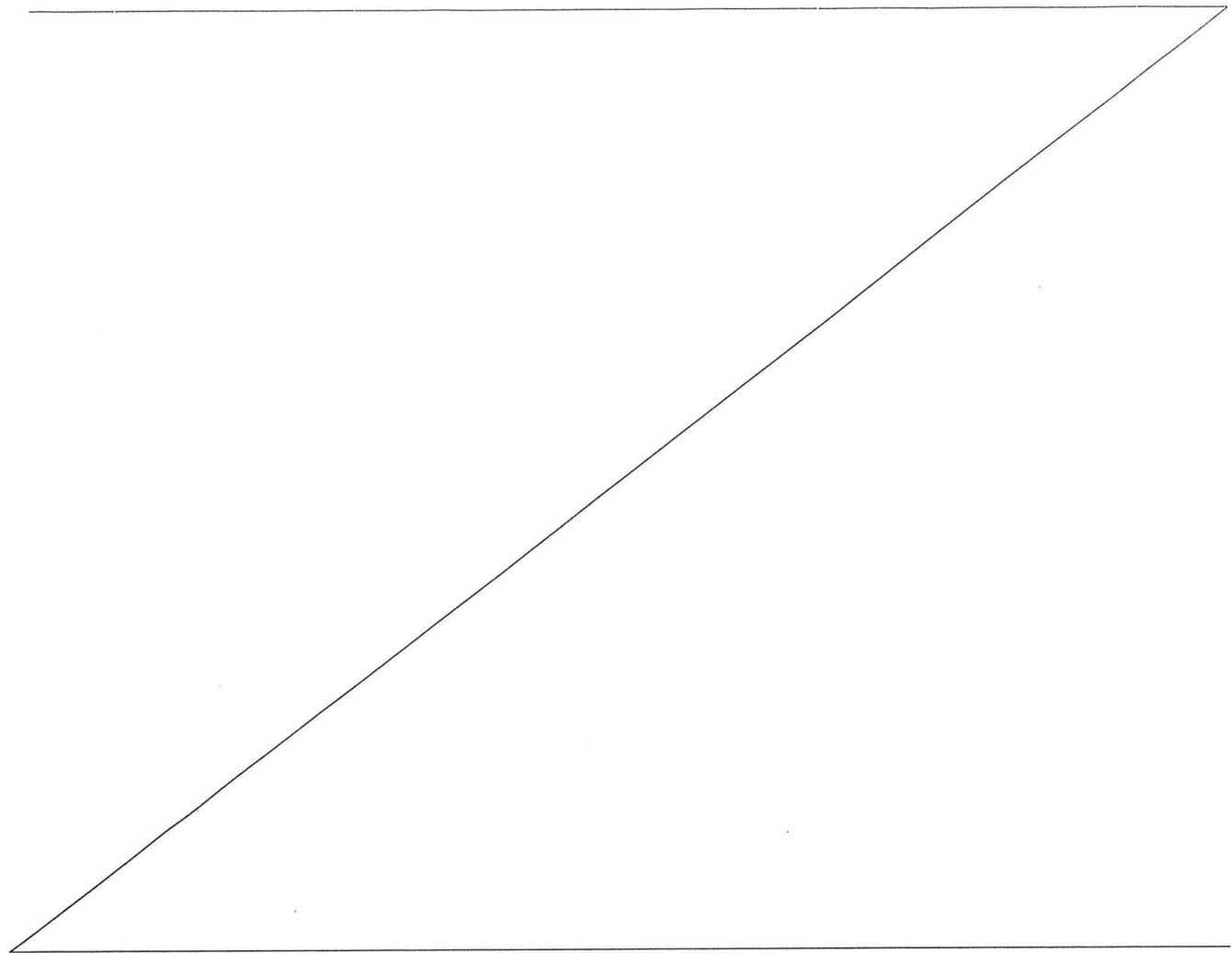


