OF THE NEVADA COUNTY SANITATION DISTRICT 1 BOARD OF DIRECTORS

AN ORDINANCE AMENDING, ADDING, AND REPEALING NON-SUBSTANTIVE SECTIONS OF THE NEVADA **COUNTY SANITATION DISTRICT CODE**

THE BOARD OF DIRECTORS OF THE NEVADA COUNTY SANITATION DISTRICT 1, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION I:

Findings and Declarations

- A. Pursuant to Division 5, Part 3, Chapter 3, Article 4 of the California Health and Safety Code, the Nevada County Sanitation District 1 ("District") may adopt and enforce ordinances for the purposes of exercise and effect of any of its powers, or for the purposes for which it was formed.
- B. Amendments to the Sanitation District Code is part of an on-going effort to recodify and reorganize provisions of the Nevada County Codes and the changes are intended to be entirely nonsubstantive in effect.

SECTION II:

- 1. Title 4 of the Sanitation District Code, containing Chapters 1 through 8 listed below, are hereby revised and amended to read as shown in "Exhibit A" attached hereto and incorporated herein by reference.
 - Chapter 1 "GENERAL PROVISIONS"
 - Chapter 2 "REGULATION OF CONNECTIONS"
 Chapter 3 "REGULATIONS OF DISCHARGES"

 - Chapter 4 "USER FEES AND CHARGES"
 - Chapter 5 "EQUIVALENT DWELLING UNITS"
 - Chapter 6 "CODE COMPLIANCE, INSPECTION AND VIOLATION PENALTY **PRÓVISIONS**"
 - Chapter 7 "DESIGN AND CONSTRUCTION STANDARDS"
 - Chapter 8 "ANNEXATION POLICY"

SECTION III:

Severability. If any provision of these Articles or the application thereof to any person or circumstance is held invalid, the remainder of these Articles, including the application of such part or provision to other circumstances shall not be affected thereby and shall continue in full force and effect. To this end, provisions of these Articles are severable. The Board of Supervisors hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase hereof irrespective of the fact that any one (1) or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be held unconstitutional, invalid or unenforceable.

SECTION IV:

This Ordinance shall be passed and adopted immediately after notice and a public hearing as required by statute, and shall take effect and be in force at the expiration of thirty (30) from and after its passage, and shall become operative on the 7th day of December, 2023 and before the expiration of fifteen (15) days after its passage a summary shall be published once, with the names of Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
