SUBJECT: Resolution approving Amendment No. 1 to the Community Care

Expansion (CCE) Preservation program funding agreement, to extend the obligation and expenditure dates for program funds and authorizing the Housing and Community Services Director to execute Amendment No. 1 and any future amendments to the agreement to promote preservation of adult and senior care facilities in Nevada County

serving low-income residents.

RECOMMENDATION: Approve the attached resolution.

<u>FUNDING</u>: Amendment No. 1 does not impact funding for this agreement. These funds are within the department's budget and there are no County general funds required in the Agreement.

BACKGROUND: On December 5, 2023, per Resolution 23-577, the Nevada County Board of Supervisors approved funds in the amount of \$418,403 and authorized the Nevada County Housing and Community Services Director to sign and execute the program funding agreement to promote preservation of adult and senior care facilities in Nevada County serving low-income residents.

Pursuant to AB-172, in January 2022, the California Department of Social Services released a Joint Request for Applications for the CCE Preservation program administered by the California Department of Social Services. Funds were made available to local public entities, including cities, counties, or other local public entities within California to acquire and rehabilitate real estate assets to expand the behavioral health continuum of treatment and service resources for vulnerable populations, including people experiencing homelessness.

In March 2022, the County applied for CCE Preservation funding and was awarded \$418, 403 for both operating and capital projects to preserve residential care facilities for adults and seniors.

The California Department of Social Services contracted grant program administrator, HORNE, issued an amendment to the program funding agreement extending the obligation and expenditure deadlines for program funds.

It is recommended that the Board of Supervisors approve Amendment No. 1 to the Community Care Expansion (CCE) Preservation program funding agreement, in the amount of \$418,403, to extend the obligation and expenditure dates for program funds and authorize the Housing and Community Services Director to execute any future amendments to the agreement to promote preservation of adult and senior care facilities in Nevada County serving low-income residents.
