**APPROVAL OF AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND KIMLEY-HORN AND ASSOCIATES INC. FOR PROFESSIONAL DESIGN AND ENGINEERING SERVICES FOR THE ROADWAY SAFETY AND SIGNING AUDIT PROJECT - PHASE 2**

WHEREAS, the Board of Supervisors, by Resolution 17-224, approved a Personal Services Contract with Kimley-Horn and Associates Inc. for professional engineering and design services for the Roadway Safety Signing Audit Project - Phase 2 in the amount of \$290,420.96 ("Agreement"); and

WHEREAS, the contract was for an amount not to exceed \$290,420.96 over the period of May 23, 2017 thru December 31, 2017; and

WHEREAS, the parties desire to extend the contract term to December 31, 2019; and

WHEREAS, funding is available in budget accounts: 1114-30154-702-1000 540711

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors approves Contract Amendment No. 1 to the Agreement between the County of Nevada and Kimley-Horn and Associates, and authorizes the Chair of the Board of Supervisors to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT NO. 1 WITH

THIS AMENDMENT No. 1 is executed this 12<sup>th</sup> day of December, 2017, by and between KIMLEY-HORN AND ASSOCIATES INC. and COUNTY OF NEVADA. Said Amendment No. 1 will amend the Personal Services Contract between the parties entitled Professional Engineering and Design Services for the Roadway Safety Signing Audit Project – Phase 2 executed by Resolution 17-224 on May 23, 2017 in the amount of \$290,420.96.
