RESOLUTION AMENDING AUTHORIZED PERSONNEL STAFFING RESOLUTION 23-338, AS AMENDED

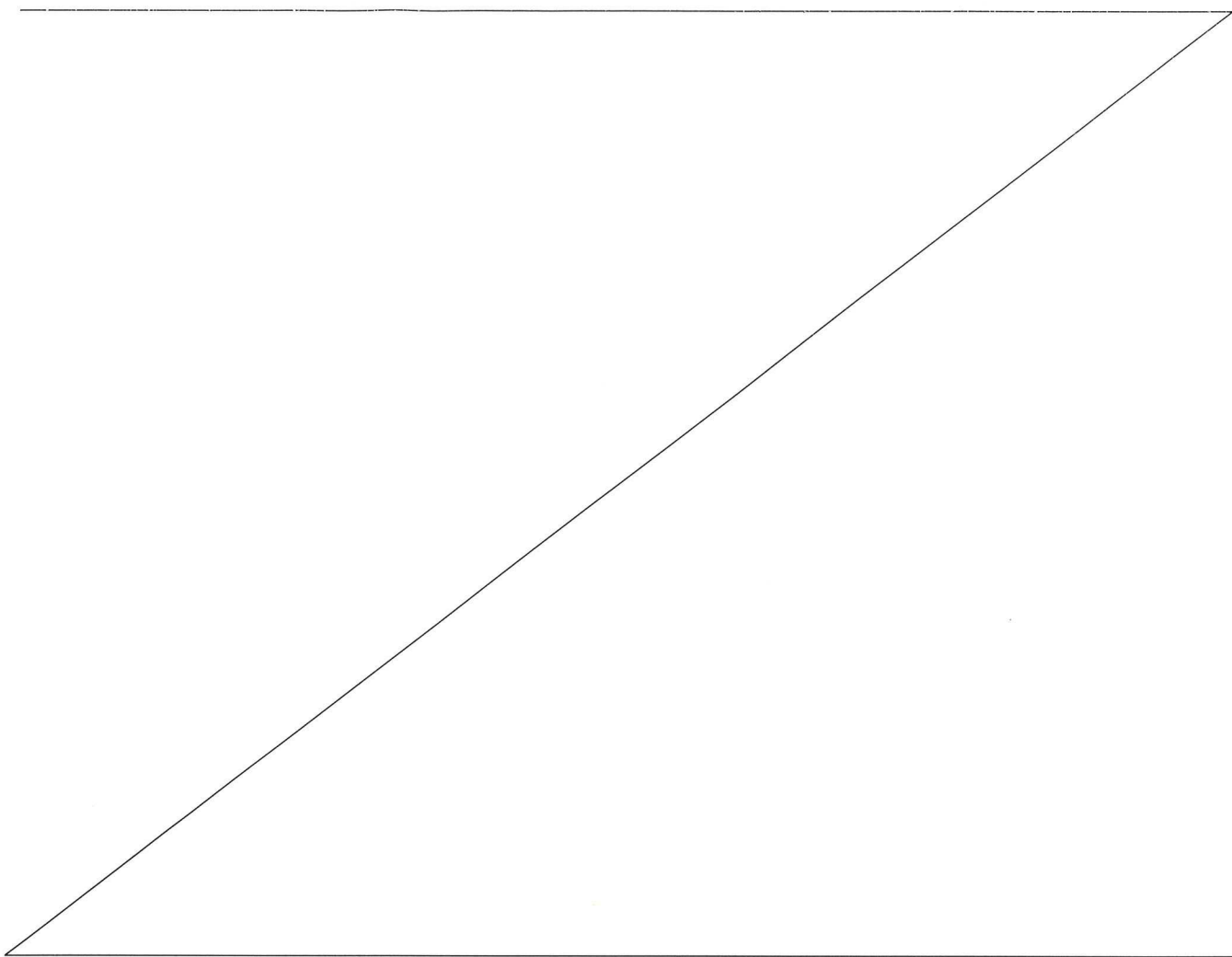
