## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING THE EXECUTION OF GRANT AGREEMENT EA28-17-0010 WITH THE CALIFORNIA DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY (CALRECYCLE) FOR THE SOLID WASTE LOCAL ENFORCEMENT AGENCIES (LEA) ENFORCEMENT ASSISTANCE GRANT FOR THE PERIOD JULY 1, 2017 THROUGH OCTOBER 29, 2018, IN THE AMOUNT OF \$17,308.00

WHEREAS, funds have been established by Public Resources Code Section 43230 and are available from the California Department of Resource Recycling and Recovery (CalRecycle) for grants to Local Enforcement Agencies (LEA) to support solid waste facilities permit, inspection and enforcement programs; and

WHEREAS, the Nevada County Board of Supervisors has authorized the Director of Environmental Health to apply for the LEA Enforcement Grant for a period of five years, or through the 30<sup>th</sup> EA cycle by Resolution 14-430 approved by the Nevada County Board of Supervisors on September 9, 2014; and

WHEREAS, Nevada County has applied for and received an LEA grant for each of the past several years, and is currently in the twenty-seventh LEA Enforcement Assistance Grant cycle, (EA 27); and

WHEREAS, the CalRecycle has identified the upcoming grant cycle as EA 28, the term of the Grant Agreement being from July 1, 2017 to October 29, 2018; and

WHEREAS, the Nevada County Department of Environmental Health has determined that funds from the grant for Fiscal Year 2017-18, in the total amount of \$17,308.00, are to be spent on tangible goods, specific program expenses and to offset the cost of unrecoverable investigation costs; and

WHEREAS, Grant No. EA28-17-0010 has been awarded in the amount of \$17,308.00 for the period of July 1, 2017 to October 29, 2018; and

WHEREAS, Grant funding will be deposited into 1123-40108-323-1000/445020.

## NOW, THEREFORE, BE IT HEREBY RESOLVED:

- 1. That the Nevada County Board of Supervisors accepts the grant funding and authorizes the Chair of the Board to execute said Grant Agreement EA28-17-0010 with the California Department of Resources Recycling and Recovery (CalRecycle) for the period of July 1, 2017 through October 29, 2018 in the amount of \$17,308.00; and
- 2. The Chair of the Board of Supervisors authorizes the Director of Environmental Health, or her designee, to execute additional documents necessary to implement the grant.
