Chairman Weston noted that CDBG grant funds would have originally provided funding for fire protection projects in the North San Juan area, and he wanted to verify that there will be an income sample taken of the residents in the area. Ms. Garcia concurred that that review will take place.

Mr. Heggarty clarified that the people in Odyssey House are seriously mentally ill individuals and it is transitional housing while permanent housing is being found.

#### Clerk-Recorder/Registrar of Voters: Gregory Diaz

Public hearing to consider and establish a new Electronic Recording Fee for the Nevada County Clerk-Recorder, and amend the Clerk-Recorder's Fee Schedule accordingly. The proposed update will affect each official instrument that is recorded by the County for the purpose of establishing an Electronic Recording Delivery system. The proposed fee relates to the cost of recording documents and reflects the increased cost of labor, materials and overhead. The proposed fee will increase the cost for each recorded document by \$1.00.

(Introduce/Waive further reading) An Ordinance amending Section A-II 24.8 of Article 24 of Chapter II of the Administrative Code of the County of Nevada pertaining to County Clerk-Recorder Fees for services.

First reading held.

ACTION TAKEN: Chairman Weston introduced the agenda item, and Mr. Gregory Diaz, Nevada County Clerk-Recorder/Registrar of Voters, reviewed the staff report for both Agenda items 28a and 28b regarding the electronic recording process and the proposed increase to the Electronic Recording fee. He provided information about how the electronic process can make recording much faster and easier for staff and for the public, providing speedier recording for home sales with better efficiency and security for all documents. He requested the Board waive further reading of the proposed Ordinance and adopt the associated Resolution.

Board questioning ensued.

Mr. Diaz clarified that there will be no actual change in the recording fee to the public; within the current fee there has been an extra \$1.00 fee that covers truncating social security numbers from documents. This \$1.00 fee will sunset in December 31, 2017, and the proposed fee increase will take its place.

Chairman Weston opened the public hearing for public comment. There being no public comment, Chairman Weston closed the public comment period.

He explained that although there are dead trees throughout the County, there is no longer enough damage to receive the Disaster Act funding. Mr. Monaghan reported that the rains of the past winter did wonders to help the drought and bark beetle situation. Nevada County has been fortunate to be under the level of tree damage that has impacted other counties, and does not meet the criteria to continue the emergency. The County is able to take care of the damaged trees with resources within the County budget.
