OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT WITH INTERFAITH FOOD MINISTRY (IFM) OF NEVADA COUNTY (RES. 16-299)

WHEREAS, per Resolution 15-276, the Board of Supervisors approved the 2016/17 Nevada County Community Action Plan (CAP) and subsequently the County was awarded Community Services Block Grant (CSBG) funding to support the County's aligned CSBG priorities and social services goals as outlined in the County's CAP; and

WHEREAS, per Resolution 16-299, the Board of Supervisors approved a CSBG funded personal services contract with Interfaith Food Ministry which seeks to increase the quantity and quality of protein rich food products available to food insecure individuals within Nevada County; and

WHEREAS, the parties desire to amend their Agreement to increase the maximum contract price and revise Exhibit "B" Schedule of Charges and Payments.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County and Interfaith Food Ministry (IFM) of Nevada County pertaining to increasing the maximum contract price from \$63,600 to \$75,260 (an increase of \$11,660) and revising Exhibit "B" Schedule of Charges and Payments for the contract term of July 1, 2016 through June 30, 2018 to increase the quantity and quality of protein rich food products available to food insecure individuals as part of Interfaith Food Ministry's Hunger to Health Project, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT #1 TO THE PERSONAL SERVICES CONTRACT WITH
INTERFAITH FOOD MINISTRY (IFM) OF NEVADA COUNTY
(RESO NO. 16-299)**


THIS AMENDMENT is dated this day of 1st day of December 2016 by and between Interfaith Food Ministry (IFM) of Nevada County, hereinafter referred to as "Contractor", and County of Nevada, hereinafter referred to as "County". Said Amendment will amend the prior Agreement between the parties entitled Personal Services Contract, executed on June 28, 2016, per Resolution No. 16-299; and

WHEREAS, the parties desire to amend their agreement to increase the maximum contract price from \$63,600 to \$75,260 (an increase of \$11,660) as there are additional CSBG dollars available to support worthwhile community projects.


NOW, THEREFORE, the parties hereto agree as follows:

- 1) That Amendment #1 shall be effective as of December 1, 2016.
- 2) That Section (§2), Maximum Contract Price, shall be changed to the following: \$75,260.
- 3) That Exhibit "B", Schedule of Charges and Payments, shall be amended to the revised Exhibit "B" hereto attached and incorporated herein.
- 4) That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

EXHIBIT "B"
SCHEDULE OF CHARGES AND PAYMENTS
INTERFAITH FOOD MINISTRY OF NEVADA COUNTY

Subject to the satisfactory performance of services required of Contractor pursuant to this Agreement, and the terms and conditions set forth in this Agreement, the County shall pay Contractor a maximum amount not to exceed \$75,260 for the entire contract term. Of this amount \$27,560 is allocated from CSBG Standard Agreement 16F-5029 for the period of July 1, 2016 through April 30, 2017; \$31,800 is allocated from CSBG Standard Agreement 17F-2029 for the period of January 1, 2017 through December 31, 2017; and \$15,900 is allocated from the anticipated 2018 CSBG Standard Agreement for the period of January 1, 2018 through June 30, 2018. The contract maximum is based on the following project budget:

Amount requested from CSBG Funding	Protein rich food products
\$75,260	County Total Contract Obligation \$75,260

The contract maximum is contingent and dependent on County receiving anticipated annual CSBG program funding. In addition, this Agreement is subject to any additional restrictions, limitations or conditions enacted by or imposed by the state or federal governments that may affect the provision, terms or funding of this Contract in any manner.

All payments shall be made on a reimbursement basis for expenses incurred by Contractor for project expenses. Contractor shall submit monthly invoices to County for actual expenditures incurred during the prior month. Payment shall be made within thirty (30) days of receipt and approval of invoice and any required report needed for that period. The County shall retain the final 5 % of the total contract amount to be paid to the Contractor upon submission of all grant required reporting to the County as contained in the enclosed Exhibits. All invoices are due to the County by within 10 days of the above allocated time periods.
