I, EVELYN HUGHES ANDERSON, currently a resident of Nevada County, California, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I have previously made.

SECOND: I am an unmarried woman, and I have no children, either living, deceased, or adopted.

I have a deceased sister, namely Helen Dart, who has issue surviving, namely, ROBERT DART; a deceased brother, namely, Parker Hughes, who has issue surviving, namely, MARGARET BELL; and, a deceased sister, namely, Carol Hughes Meyer, who has issue surviving, namely, MARJORIE LEMMON. I also have a niece, namely, Lois Lapham, whose status and whereabouts are unknown.

All of my nieces and nephews are over the age of eighteen (18) years.

THIRD: I give my entire estate, both real and personal property, wheresoever situated, as follows:

a) I give the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) to the NEVADA COUNTY LIBRARY FOUNDATION, Nevada County, California, to supplement programs for building and facilities improvements in Grass Valley, California.

b) I give the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) to ANIMAL SAVE, a California non-profit

corporation, Grass Valley, California, for the use and benefit of the local communities.


c) I give all of the rest, residue and remainder of my estate, both real and personal property, wheresoever situated, including any lapsed devises, to the SALVATION ARMY, Del Oro Division, Sacramento California, to be used for its programs and services in the Grass Valley, California, area.

d) Notwithstanding the above provisions of this Paragraph FOURTH, if, upon my death, I leave a memorandum requesting that certain items of my tangible personal property be given to certain donees, said items shall be distributed accordingly.

FIFTH: I nominate the Del Oro Divisional Commander of the Salvation Army, as Executor of this Will, to serve without bond. If for any reason he shall fail to qualify or cease to act as Executor, the Salvation Army shall have the power to nominate the personal representative of my estate, said nominee also serving without bond.

I authorize the personal representative of my estate to sell, at either public or private sale, with or without notice, and to lease any property belonging to my estate, subject only to such confirmation of Court as may be required by law.
