WHEREAS, said contract for the removal and pruning of 74 trees was completed in accordance with the plans and specifications; and

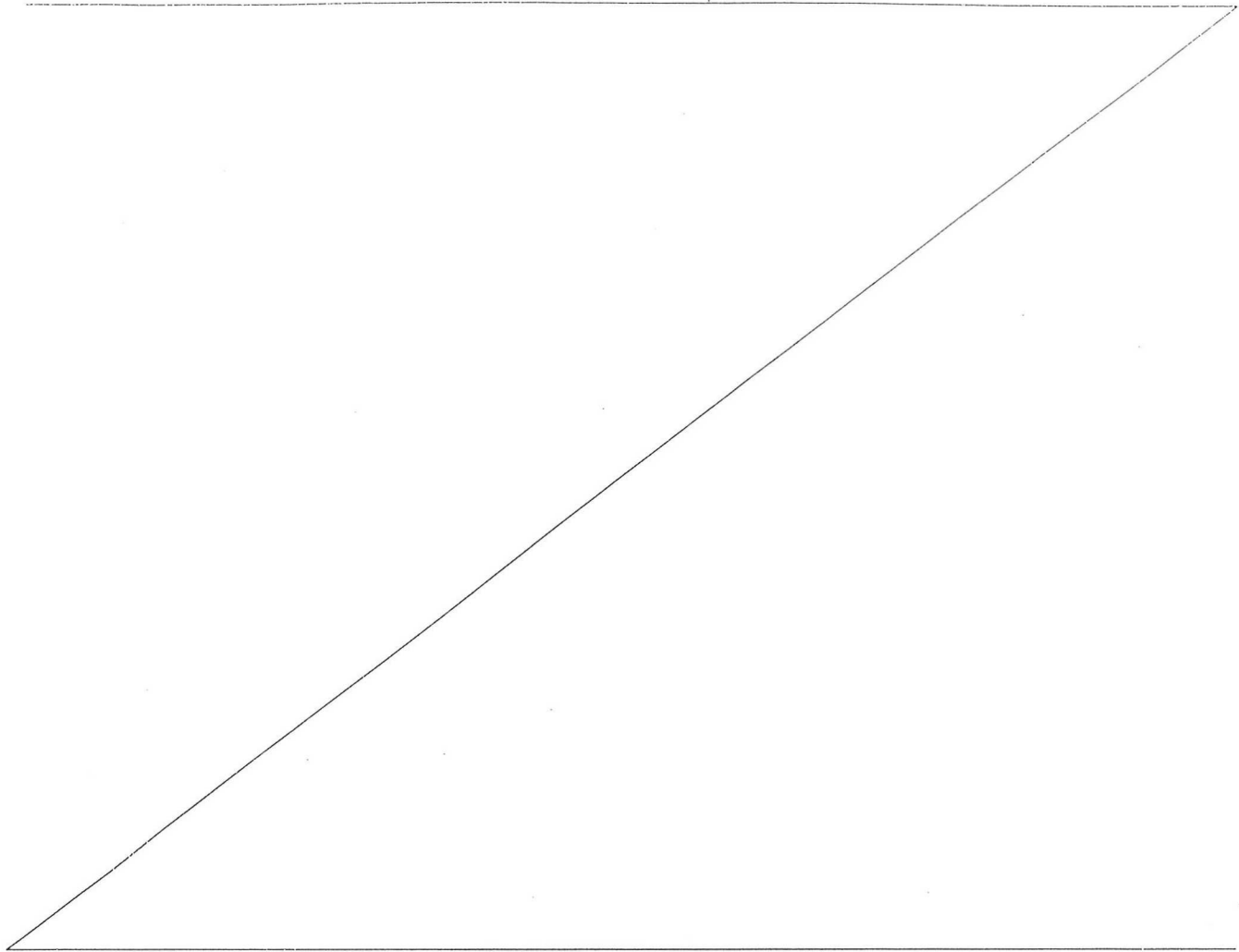
