Mr. Jeffrey Thorsby, Senior Management Analyst, reviewed the staff report and a PowerPoint presentation regarding the updated bylaws for the Nevada County Historical Landmarks Commission, and two proposed designations of the McGlashan Butterfly Collection and St. Paul Lutheran Cemetery and Church Site. He reported that the purpose of the revised bylaws is to include designation of historical resources as a part of the Commission's scope and purpose, to preserve and promote the historical significance of both local landmarks and resources. Mr. Thorsby reviewed the history of the McGlashan Butterfly Collection, which is currently located at the Truckee-Donner Park and Recreation District, and reported on the historical significance of the St. Paul Lutheran Cemetery and Church Site.

Mr. Bernie Zimmerman, Chair, and Ms. Barbara Czerwinski, Vice Chair, provided comments regarding the historical resource and landmark. Mr. Zimmerman shared that the Commission also had an interest in an additional revision to their bylaws to allow the designation of historically significant individuals. The Commission agreed to wait until the coming year to further revise their bylaws in order to provide County staff time to review their request. Mr. Zimmerman and Ms. Czerwinski requested the Board designate the McGlashan Butterfly Collection as Nevada County Historical Resource NEV 20-05, and the St. Paul Lutheran Cemetery and Church Site as Nevada County HIstorical Landmark NEV 20-06.

# Sheriff-Coroner/Public Administrator: Shannan Moon

Public community forum, pursuant to Government Code section 7283.1(d) to provide information to the public about Immigration and Customs Enforcement (ICE) access to individuals and to receive and consider public comment.

Accepted.

ACTION TAKEN: Nevada County Sheriff Shannan Moon introduced Sheriff's Lieutenant Robert Bringolf who provided a PowerPoint presentation on the Truth Act, an acronym for the Transparent Review of Unjust Transfers and Holds, relating to the Sheriff's mandated roll with regards to the Immigration and Customs Enforcement's (ICE) process. Lt. Bringolf provided corrections data for the year 2019. He summarized the data, noting that in 2019 the Nevada County Sheriff's office served 15 ICE Request and Comply forms; 1 Consent for Interview form; and 1 Notification of Release form. Lt. Bringolf reviewed the demographics of the inmates and reported on the ICE statistics for 2019. Of those inmates that had some level of involvement with ICE, there were 20 bookings and 18 releases. He concluded his presentation.

(Ms. Julie Patterson Hunter, Clerk of the Board, later noted that no public provided comments were received in response to the Community Forum, and no members of the public were waiting to provide comments.)

ACTION TAKEN: Ms. Trisha Tillotson, Director of Public Works, provided a PowerPoint presentation regarding the proposed transfer of Nevada County's Rule 20A credits to the City of Nevada City, for the conversion of existing overhead electrical facilities to underground facilities, as well as the installation of new underground electrical lines. She reported that the City submitted a request for \$500,000 in Rule 20A credits to assist completion of the East/West Broad Street Intersection Undergrounding Project. Ms. Tillotson explained that staff will develop a long-term plan for the remaining 20A funds to incorporate projects into the Capital Improvement Plan, and/or suggest further Memorandum of Understandings with the Cities of Nevada and Grass Valley. She recommended the Board approve the transfer of Nevada County's credits.

ACTION TAKEN: Ms. Trisha Tillotson, Director of Public Works, provided a PowerPoint presentation regarding updates to the County's Road Standards to require the construction of telecommunication and broadband conduit, in areas where it makes sense such as along major roadways and within new subdivisions. She reported that staff met with County partners and interested parties, which resulted in significant changes to the proposed updates. The revisions specify general utility placement along County roads, and clarifies telecommunication and broadband conduit requirements and specifications. Ms. Tillotson recommended the Board approve the resolution authorizing environmental clearance for amendments to Chapter XVII of the Land Use and Development Code, Road Standards, and introduce/waive further reading of the proposed Ordinance.

Board questioning and discussion ensued.

ACTION TAKEN: Mr. Caleb Dardick, Project Administrator for the County Executive Office, provided a PowerPoint presentation regarding the Nevada County Relief Fund in coordination with Co-Chairs of the Community Advisory Council (CAC), Mr. Leo Granucci and Ms. Sherry Bertolucci, and Ms. Kristin York, Vice President, Sierra Business Council (SBC). Mr. Dardick reported that the "Small Business Winter Survival" campaign was launched on December 2, 2020 to raise desperately needed funds to support small, locally-owned businesses hardest hit by the COVID-19 pandemic. For-profit businesses who are complying with public health guidelines are eligible to apply for micro-grants up to an amount of \$5,000 to cover rent or other critical business expenses need to stay open through the winter.

Sierra Nevada Memorial Hospital Foundation (SNMHF) is serving as the Relief Fund's fiscal sponsor, which ensures that all donations made are tax deductible. SBC is partnering to administer the grant application process, and CAC provides oversight for the final award allocations. Staff is requesting authorization from the Board to provide a matching grant in the amount of \$100,000 to support the work of the Nevada County Relief Fund.

Board questioning and discussion ensued.

Chair Hall provided an opportunity for public comment, and Ms. Julie Patterson Hunter, Clerk of the Board, reported that the Board received letters of support from the following individuals: Ms. Melinda Booth, Executive Director, South Yuba River Citizens League; Ms. Julie Baker, Community Advisory Council member; and Ms. Lynn Saunders, President/CEO, Truckee Chamber of Commerce. There being no further members of the public waiting to provide comments, Chair Hall closed provide comment.

Resolution recognizing Nevada City Rancheria Nisenan Tribe's historical, cultural and continued significance to Nevada County and California, and supporting the restoration of Federal recognition of the Nevada City Rancheria Nisenan Tribe.

Adopted.

Enactment No: RES 20-533

ACTION TAKEN: Chair Hall was very excited that she and Supervisor Hoek were bringing this item forward, to recognize the historical, cultural, and continued significance of the Nevada City Rancheria Nisenan Tribe in Nevada County and the State of California, and to support the restoration of Federal recognition of the Nevada City Rancheria Nisenan Tribe. Supervisor Hoek spoke to the importance of the Nevada City Rancheria Nisenan Tribe's historical significance to the community.

Mr. Jeffrey Thorsby, Senior Management Analyst, provided a PowerPoint presentation providing history pertaining to the Tribe's journey to have their Federal recognition restored. The Nisenan were Federally recognized until its termination per implementation of the 1958 California Rancheria Termination Act. Mr. Thorsby reported that the Nisenan seeking judicial relief to restore its Federal recognition, and he reviewed the current steps being taken to move forward towards that restoration. He noted that a total of 888 letters urging the Board of Supervisors to support the restoration of Federal recognition for the Nisenan Tribe has been received, and both the Nevada County Historical Society and Nevada City City Council have adopted Resolutions supporting the Federal acknowledgement. Mr. Thorsby recommended the Board adopt the proposed Resolution supporting the restoration of Federal recognition of the Nevada City Rancheria Nisenan Tribe.

Ms. Shelley Covert, elected officer of, and spokesperson for, the Nisenan Tribal Council, spoke to the importance of Federal recognition. Ms. Covert spoke to the importance of protecting their sovereignty and right to self-govern their own people, stressing that it is paramount to the survival of the Nisenan culture. Responding to Board questioning, Ms. Covert clarified that the Tribe currently does not own property. She further clarified that the Tribe has no interest in, or plans to, open a casino.

Chair Hall provided an opportunity for public comment, and the following members of the public spoke: Ms. Janet Bullock, District III resident; Ms. Lindsay Bellows, District III resident; Ms. Daniella Fernandez, Nevada City Council member; Ms. Tracy Pepper, District III resident; and Nevada City Mayor Erin Minett. There being no more members of the public waiting to speak, Chair Hall closed public comment.

MOTION: Motion made by Supervisor Hoek, and seconded by Supervisor Scofield, to adopt Resolution 20-533. On a roll call vote, the motion passed unanimously.

(Dist. III)

Public hearing held.

ACTION TAKEN: Chair Hall called the meeting back into order, and Mr. Tyler Barrington, Principal Planner, provided a PowerPoint presentation regarding the proposed General Plan amendment and rezone for property owned by Mr. Ian Gray, located at 13115 Ridge Road, Grass Valley, CA 95945.

Mr. Barrington provided background concerning the property in question, which was formerly owned by the Nevada County Consolidated Fire District (NCCFD). In 2015, NCCFD Board of Directors came before the Board requesting a General Plan Amendment, proposing to change the zoning from Public to Commercial. At that time, the Board did not believe the proposed business was correct for the location, and took no action on the project.

Mr. Barrington reported that the current owner is requesting a General Plan Amendment, to change the zoning from Public to Residential, and a Zoning District Map Amendment, to change the zoning from Neighborhood/Commercial to Single Family Residential. In addition, a Petition for Exceptions to the County Driveway Standard is proposed to allow for a reduced driveway width. He Barrington added that the application was reviewed and approved by the Nevada County Planning Commission in November 2020. The property is located within the City of Grass Valley's sphere of influence and therefore the Project was first brought to the City to request as to whether or not they would like to annex it; the City chose not to annex it due to its distance from City infrastructure. Surrounding uses are primarily Residential in nature with a few pockets of Commercial, most notably the Alta Market. Mr. Barrington recommended the Board approve the Resolution for the Negative Declaration; General Plan Amendment; Zoning District Map Amendment; and Petition for Exceptions to the County Driveway Standard.

Board questioning and discussion ensued.

Chair Hall opened the public hearing for public comment, and no members of the public were waiting to speak. Chair Hall closed the public comment portion of the public hearing and asked for motions from the Board to adopt the proposed Resolutions and Ordinance.

**50.** SR 20-3578 Resolution approving the filing of Application(s) for Per Capita Grant funds.

Adopted.

Enactment No: RES 20-537

ACTION TAKEN: Brian Foss, Planning Director, introduced the agenda item regarding the Proposition 68 Per Capita Grant Program administered through the State of California Department of Parks and Recreation. Mr. Foss explained that staff would request the adoption of a Resolution agreeing to the terms of the Proposition 68 Per Capital Grant contract and direction from the Board regarding facilitation of a Request for Proposal (RFP) process for fund allocation and distribution.

Ms. Jake Jacobson, Western Nevada County Recreation Coalition consultant, provided a PowerPoint presentation regarding the Program. She reported that the Per Capita Grant Program originated from Proposition 68, a \$4 billion general obligation bond act that was passed by voters on June 5, 2018. Per Capita funds are awarded to eligible grantees on a population basis. The Cities of Grass Valley and Nevada City, the Town of Truckee, Bear River Recreation and Park District, Oak Tree Park and Recreation District, Truckee-Donner Recreation and Park District, and Western Gateway Recreation and Park District were all allocated the minimum amount of \$177,952. The County of Nevada was allocated the minimum amount of \$400,000. Funds are to be used for Capital Outlay Projects, and should result in local park rehabilitation, creation, and improvement.

Ms. Jacobson reviewed the Grant process timeline: 1) Pass the authorizing Resolution at today's meeting; 2) Submit the project application package(s) by December 2021; 3) Execute the contract by June 2022; and 4) Complete the project by December 2023. In July, staff prepared a list of potential projects, and the Grass Valley Veteran's Hall main floor (\$160,000) was identified as most qualified. Staff involved the Western Nevada County Recreation Coalition and the Town of Truckee to ensure there were no missed opportunities for collaboration or impact.

Staff recommended the Board approve the authorizing resolution; authorize staff to prepare a project application to replace the Grass Valley Veteran's Building main floor; provide direction on use of Per Capita funds for rebuilding the Independence Trail; and provide direction regarding the development of an RFP process to solicit requests from eligible grantees for the remaining County funds. Staff would provide a progress report the annual Board's Annual Workshop.

Board questioning and discussion ensued.

Chair Hall provided an opportunity for public comment, and the following members of the public spoke: Ms. Dawn Zydonis, Nevada City Parks and Recreation Manager; and Ms. Erika Seward, Co-Executive Director, Bear Yuba Land Trust. Julie Patterson Hunter, Clerk of the Board, reported that one email in support of the Project was received from Mr. Steve Randall, General Manager, Truckee-Donner Recreation and Park District. There being no further public comment, Chair Hall closed public comment.

Mr. Foss requested a recap of the direction from the Supervisors, and Chair Hall summarized that the Supervisors were in support of the RFP process, and were interested in moving forward with the Veterans Hall Project and the Independence Trail Project as proposed.

MOTION: Motion made by Supervisor Miller, and seconded by Supervisor Hoek, to adopt Resolution 20-537. On a roll call vote, the motion passed unanimously.
