RESOLUTION APPROVING ACCEPTANCE OF THE FISCAL YEAR 2024 HOMELAND SECURITY GRANT PROGRAM FROM THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FUNDED THROUGH THE U.S. DEPARTMENT OF HOMELAND SECURITY IN THE AMOUNT OF \$159,879 FOR USE DURING THE PERIOD SEPTEMBER 1, 2024, THROUGH MAY 31, 2027, RETROACTIVELY AUTHORIZING THE DIRECTOR OF EMERGENCY SERVICES TO EXECUTE THE GRANT AGREEMENT AND ALL ADDITIONAL DOCUMENTS REQUIRED TO FULFILL THE REQUIREMENTS OF THE GRANT ON BEHALF OF THE COUNTY OF NEVADA

WHEREAS, the Department of Homeland Security is funding a grant through the California Governor's Office of Emergency Services to provide funding to prevent, protect against, mitigate, respond to, and recover from acts of terrorism and other catastrophic events; and

WHEREAS, Resolution 24-149 approves individuals as authorized officials to execute applications and documents for Department of Homeland Security Programs; and


WHEREAS, the Nevada County application was approved by the California Governor's Office of Emergency Services and Notification of Approval has been signed and received on October 29, 2024; and

WHEREAS, each Operational Area must appoint an Anti-Terrorism Approval Body to have final approval on the implementation of HSGP funds; and

WHEREAS the Approval Body shall consist of representatives from local law enforcement, fire agencies and public health.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby directs:

- 1. That the County of Nevada accept the grant in the amount of \$159,879 for the grant period September 1, 2024, through May 31, 2027.
- 2. The Director of Emergency Services is approved retroactively to sign the grant acceptance.
- 3. That the Director of Emergency Services, the Director of Information and General Services, and the County Executive Officer are authorized to fulfill the requirements of the FY 2024 Homeland Security Grant Program.
- 4. That the Auditor-Controller deposit grant funding in the amount of \$159,879 into the Emergency Management Budget 0101-20702-414-1000/446700 as funding is received.

This information may also be used in assessing proposals in future grant opportunities. Failure to submit required reports could result in subaward reduction, suspension, or termination.

Subrecipients must obtain additional approval **prior** to incurring costs for activities such as aviation, watercraft, allowability request logs, noncompetitive

procurement, and projects requiring Environmental Planning and Historic Preservation review.
