OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF A REVENUE CONTRACT WITH PLACER COUNTY TO SUPPORT NEVADA COUNTY'S OPERATIONS COSTS FOR A NAVIGATION CENTER PILOT IN TRUCKEE INCLUDING LEASE COSTS, TENANT IMPROVEMENT COSTS, AND CONTRACT WITH VOLUNTEERS OF AMERICA FOR THE PROVISION SERVICES INCLUDING SHELTER, INTERIM BEDS, DAY CENTER SERVICES AND SUPPORTIVE SERVICES TO THE HOMELESS POPULATION IN THE NORTH LAKE TAHOE-TRUCKEE REGION IN THE MAXIMUM AMOUNT OF \$ 75,000 FOR THE TERM JANUARY 01, 2026 THROUGH DEC 31, 2026 AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2025/26. (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, The County of Nevada and collaborative jurisdictional and faith-based partners of the Tahoe Truckee Homeless Action Coalition desire to implement Navigation Center Pilot to provide interim and drop-in shelter beds, day services, and case management to individuals experiencing homelessness in the Truckee/North Tahoe region; and

WHEREAS, Nevada County Behavioral Health has executed a lease for a site and contracted with Volunteers of America, local non-profit organization to provide a Pilot Navigation Center in Truckee that includes: shelter, interim beds, day center services and supportive services to the homeless population in the North Lake Tahoe-Truckee region; and

WHEREAS, Nevada County Behavioral Health has committed funding to support the Pilot Navigation Center; and

WHEREAS, jurisdictional partners of the Tahoe Truckee Homeless Action Coalition have committed funds to support this regional partnership; and

WHEREAS, non-profit and faith-based partners of the Tahoe Truckee Homeless Action Coalition have committed funds and on-going fundraising efforts to support this regional partnership; and

WHEREAS, Placer County has committed funds to Nevada County Behavioral Health to support the Pilot Navigation Center leasing and operations costs; and

WHEREAS, these services promote resiliency and recovery from substance use disorder, access to mental health services, and linkage to ongoing stabilizing services for the homeless population of the North Lake Tahoe-Truckee region.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California that

1. The Agreement by and between the County and Placer County for supporting a Navigation Center Pilot program in the Truckee/North Tahoe Region for the term of January 01, 2026 through December 31, 2026, in the maximum amount of \$75,000 is hereby approved in substantially the form attached hereto; and
2. The Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada; and

3. The Auditor-Controller is directed to amend the Behavioral Health Budget for Fiscal Year 2025/26 as follows:
