

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING PURCHASE OF UNMANNED AERIAL SYSTEM CAPITAL ASSETS TO BE USED IN SHERIFF OPERATIONS TO ENHANCE PUBLIC AND OFFICER SAFETY, INCLUDING BUT NOT LIMITED TO SEARCH AND RESCUE ACTIVITIES, REMOTE PATROLLING, CRITICAL INVESTIGATIONS AND SPECIAL ENFORCEMENT DETAIL, IN THE AMOUNT OF \$152,918.36 AND SHALL BE INCLUDED IN THE APPROVED AB 481 MILITARY EQUIPMENT LIST

WHEREAS, the Nevada County Sheriff's Office desires to maintain security and safety for the Public and its Law Enforcement Officers; and

WHEREAS, the Sheriff's Office desires to purchase unmanned aerial system drones, to enhance public and officer safety, and increase effectiveness in Sheriff operations through the added ability to conduct aerial reconnaissance; and


WHEREAS, the Skydio X10 drones have been selected by the Sheriff's Office as the system that is economical and most compatible with Sheriff operations, for the price including tax, training, and warranties of \$152,918.36 to be purchased from Axon Enterprises Inc.; and

WHEREAS, there are both ARPA monies and Rural Counties funds available for this purchase; and

WHEREAS, this equipment shall be included in the Nevada County Sheriff's Office list of approved AB 481 military equipment list.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors, on behalf of the County of Nevada:

- 1) Approves the purchase of an unmanned aerial system in the amount of \$152,918.36; and
- 2) Authorizes the Purchasing Agent to encumber the funds, issue a purchase order and sign any documents related to the purchase; and
- 3) Approves the unmanned aerial system drones (4) as capital assets; and
- 4) Includes the unmanned aerial system drones in the approved list of AB 481 military equipment list.
