RESOLUTION APPROVING AN UPDATED AUTHORIZED AGENT FORM FOR THE CALIFORNIA PROPOSITION 1B PUBLIC TRANSPORTATION MODERNIZATION, IMPROVEMENT, AND SERVICE ENHANCEMENT ACCOUNT (PTMISEA) PROGRAM TO EXECUTE APPLICATION(S) AND ALL REQUIRED DOCUMENTS OF THE PTMISEA PROGRAM AND ANY AMENDMENTS THERETO WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION ON BEHALF OF THE COUNTY OF NEVADA

WHEREAS, the Proposition 1B, Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) provides revenue apportionments for Nevada County which may be used for eligible capital projects; and

WHEREAS, Transit Services vehicle replacement, bus stop improvements and facility improvements are eligible and current Transit projects utilizing Proposition 1B PTMISEA funding; and

WHEREAS, the California Department of Transportation is the administrative agency for the PTMISEA Program and has developed guidelines for the purpose of administering and distributing PTMISEA funds to eligible sponsors; and


WHEREAS, the PTMISEA program requires approval, by Board Resolution, of authorized agent(s) to execute application(s) and all required documents of the PTMISEA program and any Amendments thereto with the California Department of Transportation on behalf of the County of Nevada and if there is a change in the authorized agent, a new Authorized Agent form must be submitted; and

WHEREAS, a change in the Transit Services Manager has taken place and Board approval is required for an updated Authorized Agent Form; and

WHEREAS, the County of Nevada, Department of Public Works, Transit Services Division wishes to delegate authorization to execute these documents and any amendments thereto to the Director of Public Works, Trisha Tillotson and the Transit Services Manager, Robin Van Valkenburgh.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes:

- 1. The County Executive Officer execute the PTMISEA Authorized Agent Form.
- 2. Trisha Tillotson, Director of Public Works, and Robin Van Valkenburgh, Transit Services Manager to execute the application(s) and all required documents of the PTMISEA program and any Amendments thereto with the California Department of Transportation on behalf of the County of Nevada.
