OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT 1 TO THE AGREEMENT FOR SERVICES #8848 BETWEEN THE COUNTY OF NEVADA AND THE COUNTY OF EL DORADO FOR THE PROVISION OF TELEPHONE TRIAGE SERVICES FOR EL DORADO COUNTY ADULT SYSTEM OF CARE AND CHILDREN'S SYSTEM OF CARE TO AMEND SERVICES IN ARTICLES I, II, III, IV; TO INCREASE THE MAXIMUM PAYABLE AMOUNT FROM \$50,748 TO \$182,790, FOR THE INITIAL OF PERIOD JULY 1, 2024 THROUGH JUNE 30, 2026; TO INCREASE THE MAXIMUM AMOUNT NOT TO EXCEED AMOUNT BY \$417,210 FOR THE OPTIONAL 3 YEAR EXTENSION TERM, AND AUTHORIZE THE NEVADA COUNTY DIRECTOR OF BEHAVIORAL HEALTH TO EXECUTE THE AMENDMENT

WHEREAS, on June 25, 2024, per Resolution 24-306, the Nevada County Board of Supervisors approved execution of the Agreement for Services # 8848 with County of El Dorado for the provision of work to include operation of the County Crisis Line and the County Access Line twenty-four (24) hours per day, seven (7) days per week including weekends and County holidays; and

WHEREAS, the parties desire to amend their agreement to amend Articles I,II,III, and IV, to include dispatch of the Mobile Crisis Team and increase the maximum in the payable amount from \$50,748 to \$182,790, for the initial of period July 1, 2024 through June 30, 2026 and increase the maximum not to exceed amount by \$417,210 for the optional 3 year extension period.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment 1 to the Agreement #8848 by and between the County and County of El Dorado pertaining to Nevada County Behavioral Health Department providing telephone triage services for the El Dorado County Adult System of Care and Children's System of Care for a total contractual obligation not to exceed \$182,790 for the term of July 1, 2024 through June 30, 2026, and increase the same by \$417,210 for the option extension term, be and hereby is approved in substantially the form attached hereto, and that the Director of Behavioral Health be and are hereby authorized to execute the Amendment on behalf of the County of Nevada.
